DESCRIPTION OF EVENTS - 1/17/78, 1978

We all were walking together that night. I did not want to take showers. [redacted] and Al took showers. I did not. We all went back to the tent and started to talk about gay rights. [redacted] told Al that he had to get his hand inside his sleeping bag. I know that night he got up and went outside for about 5 minutes. I could hear him giving [redacted] a hand and then Al masturbated. Then Al went to his own tent.

The four of us [redacted] Al Chippone and we went down to the showers and took showers separately. That is when Al started talking about gay rights and how he felt among these kind of people. Then we all walked back to the tent and talked about it some more. That was when Al started to grab me on my penis. That was when I rolled over and tried to avoid any other contact with Al. Then I heard Al start to approach [redacted] He had oral sex with [redacted] Then I heard [redacted] get up and light a cigar to get away from the problem. I tried to go to sleep.

We went to the showers along with Al Chippone because we had cleaned them that day. Al talked about when he was young he had relationships with other males and that he had some friends that were gay. He tried to us to say that we had had previous experiences. I talked about a girl that was with me along time ago. Al and the rest of us went back to my tent. He said people were talking about us saying that we were gay. He said that doctors had said that what ever feels good is good. He said he wanted to go to sleep and that we should turn off the lights. I heard him fooling with my bunk mates. I went over to see what was happening. Soon I felt him going under my sleeping bag and having oral sex with my penis. I wanted to leave but in the confusion I couldn't a short time later he masturbated and left the tent.

TO WHOM IT MAY CONCERN:

REASON: Action taken on information pertaining to Al Chipone

On the evening on July 16th Mike Foster, the Aquatics Director, approached me with information about a homosexual approach by Al Chipone towards three of the waterfront staff, [REDACTED] and [REDACTED]. I called in the three staff members involved and collected their statements. I then called in all Chipone confidentially with the information. George Fleckenstein was present to witness any responses. Al was confused at the accusation but neither denied nor confirmed the account. I explained that without evidence to the contrary I would terminate his employment. His response was again non-confittal. I then requested the keys to his area and had him pack. He left within the hour.

Approximately one week later Al's dog and Al had been sighted on the property. He seemed to be hiking through to a bar on Granderry Lake. That afternoon Drew Cavanaugh brought the dog back to camp. It appeared that the dog had been left behind. The next day someone called the camp to say that Al would be by to get his dog. I sent the dog to the animal shelter before I was aware of this call. The next day I met Al at the main gate. He asked for the dog and I told him it was in Long Lake. He left immediately without an opportunity to tell him not to come back.

On August 3rd Al returned with the membership of troop 46 St. Anthony's Roman Catholic Church, to drop off the scouts staying at camp. Again he stayed with the scouts until he left, therefore not all wing me to get into a conversation about his being at camp. He left with intentions of picking up the scouts on August 7th.
