Detective J. J. Crocker, Metro Dade Police Department, called regarding the above person. Mr. Clark has been arrested, jailed and charged with:

One count - lewd and lascivious behavior

2. One count - attempted sexual assault on a five (5) year old boy.

In addition, the five (5) year old's brother was watching. The brother is seven (7). Mr. Clark was caught by the boy's father trying to insert his penis in the youngster's anus. Mr. Clark was a family friend.

# July 23, 1984 - 9:10 p.m.

John Malone called Det. Crocker. Det. Crocker stated that Mr. Clark was arrested on June 10, 1984. Also, Mr. Clark is employed as a teacher's aide with handicapped children in Dade County Public Schools and a Scoutmaster of Boy Scout Troop 259. Det. Crocker has made NO MENTION of Mr. Clark's involvement in the public schools or Scouting. We agreed that there was NO POINT in getting into that type of publicity at this point.

#### Other Information

- 1. Gregory Clark is an Eagle Scout and earned the rank on May 12, 1978 in Troop 259. He is currently registered as Scoutmaster of same troop.
- 2. Gregory Clark's address is: Bunche Park Community, 15351 N.W. Railroad Drive, Opa-Locka, Florida.

3. Gregory Clark is still in Dade County jail.

- Det. Crocker has requested a list of all boys in Troop 259.
   John Malone is to meet with Det. Crocker, 547-7814, at 3:30 p.m. on July 24, 1984 to discuss the case and his request.
