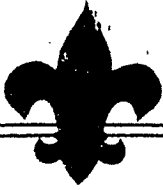

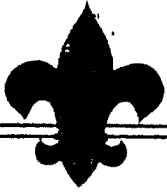

### Child molest arrest

Richard H. Williams, 21, of Ukiah, was arrested by sheriff's officials Monday in connection with a reported case of child molestation. The arrest followed a lengthy investigation.

The alleged molestation occurred sometime in October at a school in the Ukiah area where Williams was a teaching assistant in a computer class.

The victim has been described as a 13-year-old male Mendocino County resident, according to the sheriff's report.

Williams was taken to the Mendocino County Jail and later released on \$10,000 bail.

I discussed with [REDACTED] the need for verified facts in cases such as this and also suggested that the Boy Scouts of America does have a workable system to deal with such matters. June 6, 1985 I inquired to Joanne Leonard and John Marshall on a confidential basis to determine if either knew anything about Richard Williams that would be negative towards his affiliation with Scientology. Neither knew of any items that would place Richard in membership question.

June 6, 1985 [REDACTED] left a message for me to call. I did. She wasn't home.

June 6, 1985 [REDACTED] returned her call. Discussed her views of Richard Williams involvement. States that:

Her son had been a member of Troop 75 under the leadership of scoutmaster Shorty Silver. The police report was case number 82-0360, dated 2/23/82.

- 4- And discuss the matter with former Scout Executive Don Chalcraft.
