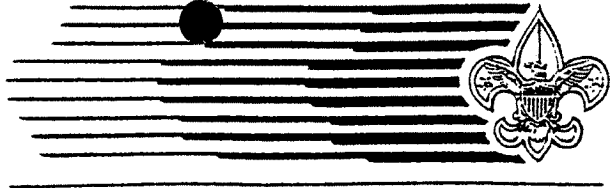

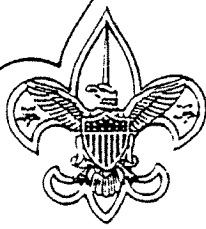

Dear Rich:

The following represents a commentary by one of the boys in Troop 5 with regard to some of the activities of Mr. Dan Wheeler, the Scout Leader of Troop 5. The commentary has been left in the boy's own words as much as possible.

"He put a rubber on himself, in front of the boys, showing them how to put one on and what it was used for. At night when the lights were out, the boys would hear a weird squeaky noise. He also put a rubber on [REDACTED]. He talked about rubbers a lot and always had them. When the boys stayed the night with him he would make them sleep alone in the motor home naked. He made them sleep on campouts in just T-shirts with no underwear, telling them they would stay warmer. Dan also slept in just a T-shirt.

He stood around the shower, handing the boys shampoo and conditioner and then he would try and dry them off. He would be naked when he did that. We always had to dress and undress in front of him. He tried to make one of the boys wear his underwear. He fooled around with himself while he was erect and then walked around with paper towels on him. He made [REDACTED] sleep in his sleeping bag with him for a half hour one night. He has a round with a hole in it that he calls his "Jacker Offer". He told some of the boys that he should have brought it with him. He also jacks off in front of them. He wanted to fit [REDACTED] to a jock strap by telling him to pop a boner. He told him to play with it because it would fill up with blood and get stiff. He made [REDACTED] and [REDACTED] sit around naked after motorcycle riding so the sweat would dry off of them. He kept trying to make [REDACTED] spread his legs apart and put his head down. [REDACTED] wouldn't so he shoved him in front of a mirror saying he doesn't have nothing that everyone else didn't have.

He always makes the boys sit around naked, and he was always naked too. The boys said Dan was always worrying about them sweating too much. He talks about his blow-up dolls and how he should have brought them to camp so everybody could have tried them and that he would like to tape a boy and girl doll together and float them in the lake. He kicked one of the boys in the head, and kicked [REDACTED] flat-footed in the butt. He's pushed them into barbed wire fences and turned on the electricity. [REDACTED] hit his head on the wire and was shocked to the point where he bit his tongue and made it bleed.

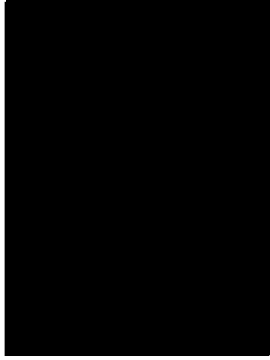
He combs the boys' hair and buys them clothes and dinner. He takes them to Church, motorcycle riding, skiing, flying... Everybody thought he was a real nice guy. Now we know why he did

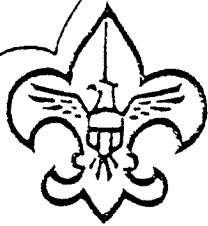
these things. He shows the boys Playboy magazines and tells them dirty jokes and says it all right to say dirt words.

Now if this is what a leader is supposed to teach boys, then my boys and the others will not be scouts any more.

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

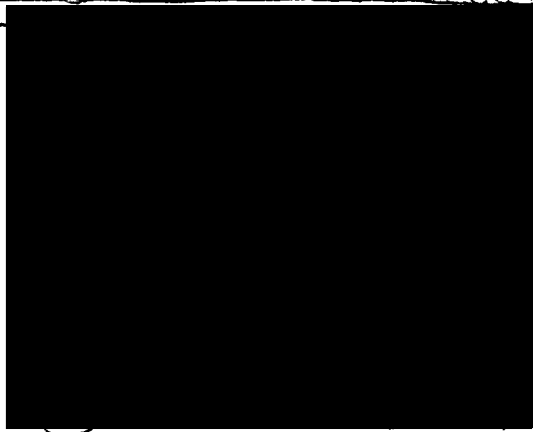

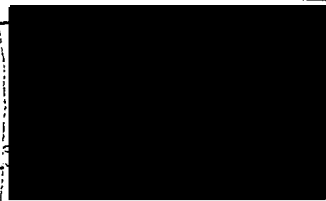
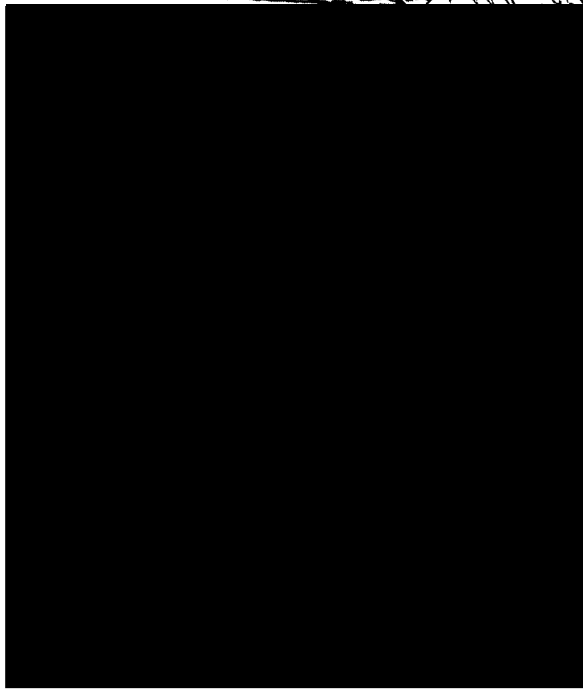
