Sumter lawyer suspended by hi

COLUMBIA (AP) — By a 4-1 vote, a Sumter lawyer who pleaded guilty to criminal sexual conduct with a minor was suspended indefinitely by the South Carolina Supreme Court.

Rodney McDowell Sprott, 32, who was employed by the law firm of Veinberg, Brown and McDougall, pleaded guilty to two indictments in May 1985. The first charged Sprott with second-degree criminal sexual conduct with a minor, contributing to the delinquency of a minor and a second act upon a child.

The second indictment charged the former scoutmaster with contributing to the delinquency of a minor.

The children involved were a 13-year-old boy and his 16-year-old

brother.

Sprott was sentenced to 10 years in prison and fined \$6,000 for the first indictment. The sentence was suspended to one year in jail, a \$3,000 fine and five years of intensive probation.

As a special condition of that sentence, Sprott was required to deposit \$4,000 to be held by the Sumter County clerk of court for up to five years. The fund was set aside for the use of the victims and their families for psychiatric or psychological evaluations.

On the second indictment, Sprott was sentenced to three years, suspended to a year and five years probation.

Sprott is serving his sentence at the Sumter County Correctional

Center.

Witnesses appearing before an earlier hearing panel on Sprott's behalf included William A. King, a psychiatrist who has been treating Sprott; House Speaker Ramon Schwartz; Jacob H. Jennings of Bishopville, a former president of the South Carolina Bar; Assistant 3rd Circuit Solicitor Thomas L. Bultman; Jerry A. Hyatt, director of the correctional center; and Reuben B. Marlowe, the pastor of Trinity United Methodist Church.

King diagnosed Sprott as a pedophile, someone who has sexual desires toward children. The disorder, while treatable, is an incurable psychiatric condition, he said.

Several of the character wit-

nesses, including Schwennings and Bultman, testified they were unaware of any wrongdoing by Sprott who had enjoyed a reputation and integrity since he began law.

Chief Justice Julius N. Ness dissented in the majority Monday, saying the punishment for Sprott was too light. Ness should have been disbarred.

"We do not discount the possibility that at some future time he may be able to conquer his condition and return to the practice of law," the majority opinion said. "At that time, he should be permitted to hold himself out to the public as a practicing lawyer."

"Disbarment would eliminate the possibility of his ever re-

Attorney charged with sex abuse

A Sumter attorney is being held under \$35,000 bond today after his arrest on charges of criminal sexual conduct, attempting or committing a lewd act upon a minor and contributing to the delinquency of a minor.

Rodney M. Sprott, 31, of 18 Park Ave., was arrested yesterday afternoon by investigators of the police department's youth division. He was charged with one count of second-degree criminal sexual conduct, one count of attempting or committing a lewd act and two counts of contributing to the delinquency of a minor.

According to police records, three of the charges stem from incidents reported by a male juvenile that allegedly occurred between September 1983 and December 1984. The fourth charge involving another person stems from an alleged incident in November 1982.

Police said the investigation began in mid-February when the parents of the victims registered a complaint. No more charges are expected.
