I know that you've probably heard a lot of words like this before. But I guess at the risk of sounding repetitive or defensive or whatever, I will never commit another crime like this again. Crime takes too much ont of a person's life, and what I've had to go through, been through, and put my wife through, my marriage, my family and everyone, crime doesn't pay. It's just too much of a cost. And I'll never go through something like this again. Thank you.

THE COURT: Contrary to what ir. Miffe says, I doubt it I ever heard a more eloquent statement on behalf of a defendant.

The statutes -- the legislature itself has set forth the factors in aggravation and mitigation which are applicable here and the attorneys have gone through most of them.

I think that ir. Fischer has pointed out the fact that two of the first four sections refer no by in. Semunacher do not - do not really fit this particular case. But, I think, the arguments presented by Ar. Schusacher and by Mr. Fischer are well taken.

The ultimate question, in view of the nature of this particular offense, is whether or not propation, a sentence of propation would depricate the seriousness of the offender's

and would be inconsistent with the ends of justice. I can frankly say, based upon all the facts which you gentlemen have argued, that had the defendant not occupied the position of trust and confidence which the victim's mother was able to rely upon at the time she placed the child with him as a minister as well as a babysitter, I would, on the evidence I've heard, be frankly predisposed towards straight probation.

The question then becomes whether or not that particular factor, that brench of a position of trust as applied to the circumstances of this particular case are sufficent to overcome the presumption of probation, and even though the offender is a first offender, I believe they are.

Accordingly, I will enter a judgment of conviction for the offense of Criminal behalf Assault and sentence the defendant to the minimum provided by law, a term of four years' imprisonment in the Illinois Department of Corrections. Court costs will be assessed in this case in the amount of \$70.00 which will be ordered paid on or before April 20, 1985 at 1:00 in the afternoon.

Mr. Fischer, may I suggest that the defendant report to the sheriff here Harch 25th at 9:00 a.m., here at the ogle County jail, here in ogle County, Illinois, for transportation to the Department of Corrections to commence serving his mini-

Ex-minister pleads guilty to sexual abuse, assault

OGLE COUNTY — A former Rochelle clergy man pled guilty to the felony offense of criminal sexual assault as he appeared in Ogle County Circuit Court Dec. 11.

David M. Riffe, 27, 98 Cornell Circle, Pueblo, Colo., represented in court by Ogle County Public Defender George Fischer, waived his preliminary hearing and pled guilty before Ogle County Associate Circuit Judge Alan W. Cargerman.

Riffe was charged? Nov. 26 with performing oral sex with a 10-year-old Rochelle boy.

Riffe had been the minister of the First Church of God, located on South Third St., Rochelle, from May 1983 to Oct. 6.

Cargernian set Riffe's sentencing meaning for Jan. 21 and reduced his north

\$30,000 recognizance.

Investigation leads to arrest

Riffe, who had been arrested in Colorado, waived extradition and was transported back to Ogle County by Rochelle Police Department Investigators.

Rochelle Deputy Police Chief Mel Messer stated that Riffe's arrest followed a two-month investigation by the police department.

Messer said that the investigation began after Rochelle detectives had received a call from the Department of Children and Family Services.

Messer noted that DCFS contacted the police department after they received a call too help from their buttons.


