NARRATIVE (Nature of Report, Interviews, Investigation at Scene, Evidence, Footnotes, Status)

NATURE OF REPORT: R/O received a phone call from a Mr. Larry Price, DOB 8/27/40. Mr. Price identified himself as an executive with the Boy Scouts of America in the Colorado Branch office. Mr. Price stated that he had been contacted by a woman who was concerned about homosexual activities between her 12 year old son and the suspect.

DETAILS: R/O made arrangements with Mr. Price to hold a telephone conversation with the woman on 2/2/76 at 9:30 a.m.

2/2/76 - At 0930 hours <sup>R/O</sup> the R/O held a telephone conversation with Mrs. [redacted], DOB 10/24/29, residence address [redacted] St., Aurora, Colo. Mrs. [redacted] stated that on Jan. 29, 1976, her son identified as [redacted], DOB 9/23/64 related to her that he had been sexually molested by David Slusher on numerous occasions while at Slushers residence in Boulder County, Colorado.

At 1400 hours R/O interviewed [redacted], he stated to R/O that he first met a suspect in late July of 1976, while attending a Boy Scout camp at Peaceful Valley Colo. On or about Sept. 5, 1976, [redacted] stated that David Slusher picked him up at his home in Aurora, Colo. at approx 11:00 a.m. and transported him to 471 Ord Street in the City of Boulder. Upon arrival at the residence the suspect gave [redacted] a beer and some vodka which resulted in [redacted] becoming intoxicated. After a short period of time, the suspect directed [redacted] to take his clothes off which in turn, [redacted] did. While [redacted] was disrobing, David Slusher also disrobed. The suspect then stated to [redacted] "what I'm going to do now, if I get arrested, after I get out of jail, I'll come after you and your family". The suspect had [redacted] lay down on the bed, David Slusher laid beside him and grasped [redacted] penis. David Slusher began to masturbate [redacted] which lasted about 10 minutes. The suspect then directed [redacted] to massage his penis which resulted in the suspect ejaculating. The suspect then had [redacted] kiss him several times while the suspect was caressing and kissing [redacted] body. [redacted] further stated that David Slusher took pictures of him while laying nude on the bed.

[redacted] stated to R/O that on or about 9/12/76 the suspect transported him to Boulder and an 11 year old friend identified as [redacted], Aurora, Colo. While at the residence of the suspect, 471 Ord, St., Boulder, Colo. the suspect directed both boys to undress while Slusher undressed. The [redacted] boy was directed to lay on the bed and read Playboy magazines and other unknown type pornographic material. The suspect and [redacted] laid on the floor where David Slusher then masturbated [redacted] after which David Slusher placed his mouth upon [redacted] penis performing felatio. [redacted] was then directed to masturbate him until David Slusher ejaculated. David Slusher then directed [redacted] and [redacted] to change places. [redacted] laid on the bed and [redacted] joined the suspect on the floor.

<sup>R/O</sup> [redacted] stated to the R/O that on or about Dec. 10, 1976, the suspect transported himself and [redacted] to 471 Ord, St., Boulder, Colo. [redacted] stated that he and [redacted] spent the night with David Slusher at his residence. On the evening of Dec. 10, 1976, the suspect had [redacted] disrob whereafter Slusher sexually molested [redacted] while in the bedroom. On the morning of Dec. 11, 1976, while [redacted] was in his sleeping bag on the floor and [redacted] was asleep on the bed, Slusher masturbated him by hand after which Slusher placed his mouth upon [redacted] penis performing felatio. David Slusher then directed [redacted] to masturbate him until David Slusher ejaculated. [redacted] stated that while at the residence, he viewed the slide pictures taken of him previously while laying nude on the bed. [redacted] stated that David Slusher informed him that he would perform intercourse on him in the near future.

NARRATIVE (Nature of Report, Interviews, Investigation at Scene, Evidence, Footnotes, Status)

DETAILS: Con't - [redacted] stated to R/O that on or about Jan. 9, 1977, David Slusher transported him to an unknown address of Slushers in the City of Boulder County Colorado. David Slusher directed [redacted] to undress while he undressed whereafter both he and Slusher laid in bed. Slusher masturbated [redacted] by hand for a few minutes after which David placed his mouth upon the penis of [redacted] performing felatio. [redacted] then was directed to masturbate David Slusher until Slusher ejaculated. During the sexual acts Slusher would caress and kiss [redacted] body. David Slusher then directed [redacted] to lay on his stomach whereafter Slusher laid on top of [redacted]. [redacted] felt the erected penis of Slusher on his anus which frightened [redacted], resulting in [redacted] squirming away from Slusher.

After each separate session of sexual episodes David Slusher threatened [redacted] that he would kill him if he told anyone about the sexual acts and that he knew it was illegal and that he could go to jail for it. [redacted] further stated that David Slusher told him that he has had sexual experiences with many young boys in Boulder County Colorado. [redacted] stated that the photographs taken of him in the nude and pornographic literature was located in the residence of Slusher. [redacted] stated that the photographs that were taken of him while nude were taken with a .35 mm camera. R/O obtained a telephone number of 494-2682 said to belong to David Slusher from [redacted]

2/3/77 - R/O contacted Mountain States Telephone Security and obtained the address listed to the 2682 number as 75 S. 35th St. Boulder, Colo. R/O confirming the residence of Slusher noted the name in the mail chute near the front door, 35th Street side, the name of David Slusher. R/O obtained an arrest warrant for the suspect charging him with four counts of sexual assault on a child. R/O issued a pick up request through dispatch requesting that the subject be taken into custody. At 1630 hours, officers of the Boulder Police Dept. identified as John Ulrich and Jan. Winkle and Det. Miller apprehended such subject at his residence. He was subsequently transported to the office of R/O. R/O advised the suspect of his rights per miranda and processed him on an arrest report. The suspect was subsequently lodged in Boulder County Corrections.

R/O obtained a search warrant for the suspects residence located at 75 S. 35th St., Boulder, Colo. in an attempt to seize Playboy magazines and any other pornographic materials, photographs or slides of nude or partially nude persons, and a .35 mm camera.

With the assistance of Det. Tom Shomaker of the Boulder County Sheriff's Dept., Sgt. Ray Smith of the Boulder Police Dept., R/O searched the residence of the suspect. It should be noted that all evidence desiring to be seized was in fact seized at the residence which included several slides of nude juvenile males, as described by [redacted]. Further seized were Playboy magazines and other pornographic materials as described by [redacted]. It should also be noted that the search warrant was served upon the landlord of the 75 S. 35th St. residence identified as Victor Sosa. Mr. Sosa stated that the suspect rents the downstairs apartment from him for a cost of \$94.00 per month. R/O obtained a rent receipt from Slusher's bedroom indicating payment for Jan. 1977 rent paid on Jan. 11.

NATURE OF REPORT: R/O continuing investigation on above case.

DETAILS: On 2/4/77, R/O held conference with [redacted], DOB 6/2/31 at the Bureau. Mr. [redacted] stated that he has been an assistant scout master in troop 75 since February of 1974 and retired from the troop in September of 1976. Mr. [redacted] stated that during the month of August, 1976, suspect took scout troop 75 to Montana upon return to Boulder his son stated that Slusher had made a "pass" at him. The incident resulted in [redacted] quitting the troop shortly after the return from Montana. Mr. [redacted] states that he is aware that the suspect left Air Force ROTC at the University of Colorado under suspicious circumstances and advised R/O to check it out. In the summer of 1975 the suspect was confronted for a possible sexual activity while at BenDelatour Scout Ranch, Red Feather lakes Colo. A Mr. [redacted] 2285 Knollwood, 443-7863, withdrew his son out of scout troop 75. Individuals on the troop committed named as John Porritt and Stan Black confronted Slusher on the questionable activity with boys at the summer camp. However, they felt that insufficient evidence existed which resulted in the matter being dropped. Mr. [redacted] viewed the slides of nude boys seized during search warrant on Slushers residence. Mr. [redacted] was able to identify three slides as being [redacted] and one slide being [redacted]. There remains eight slides to be identified.

R/O interviewed [redacted] age 13, DOB 11/1/63, residence address, 4525 Martin Drive, 494-449 [redacted] stated that he dropped from Scout troop 75 on or about 9/1/76 due to a few incidents with [redacted] suspect during the summer of 1976. [redacted] stated that during the Montana trip, with the scout [redacted] Slusher would try to hug him which he felt uncomfortable with. On one occasion, Slusher had him in a tent desiring to hug him. Slusher stated that he wanted [redacted] to do something to him. [redacted] stated "what?" and Slusher responded by stating that it began with a "K". [redacted] informed tow boys, [redacted] and [redacted], about the incident which in turn got back to Slusher. The next day, Slusher informed [redacted] that the word begining with "K" now stood for "kill". On another occasion during the same camp, Slusher, [redacted], and [redacted] were in the same tent. Slusher hugged and kissed [redacted] several times and then directed his attention to [redacted] laying on top of his sleeping bag in scout shorts, was advised by Slusher that [redacted] should take off his pants due to the warm weather. [redacted] stated that he was OK the way he was. Slusher then tried to place his arms around [redacted] which resulted in [redacted] pulling away from him. Slusher then turned his attention to [redacted] stating that [redacted] was his "teddy-bear". [redacted] stated that [redacted] was always the "pet" of Slusher and was seen quite often in the arms of Slusher. Due to [redacted] belief that Slusher was a homosexual, he dropped from the scout troop.

R/O interviewed Mr. Ronald Fisher, DOB 10/15/27, residence address, 755 S. 43rd St., Boulder, Colo. Mr. Fisher is currently the committed chairman of scout troop 73. Mr. Fisher stated that on 2/3/77, when he heard of the apprehension of suspect, he contacted what he would believe a possible victim. The boy was identified as [redacted], age 11, parents name, [redacted], residence address 4630 Mack Way, Boulder. During the conference with the boy and the parents the boy admitted to some involvement, however, he would not admit to any direct sexual involvement. Upon viewing the slides, Mr. Fisher could not identify any of the boys shown. Mr. Fisher states that Slusher had been with scout troop 73 since November of 1976.

STATUS: Investigation continuing.

NATURE OF REPORT: R/O continuing investigation of the above case.

DETAILS: R/O held a conference with [redacted], DOB 5/31/62, residence address, [redacted] Boulder, Colo., residence phone [redacted], parent name, [redacted] is a victim of Slusher.

[redacted] stated that he met the suspect through the "big brother" program at the YMCA in Boulder in February of 1972, when he was 10 years old. During that month, Slusher took [redacted] camping in the mountains west of Boulder. Slusher informed [redacted] that he wanted him to take part in some "Experiments". That evening [redacted] was directed to get into Slushers sleeping bag without any clothes which resulted in Slusher masturbating [redacted]. Slusher also directed [redacted] to masturbate him which resulted in Slusher ejaculating. [redacted] stated that Slusher stated that he would "kill him" if he told anyone about the activity. [redacted] states his last encounter with Slusher was on or about July 12, 1975. [redacted] while at Slushers residence, was directed by Slusher to get undressed which resulted in mutual masturbation. [redacted] states that just prior to Slusher ejaculating, Slusher would lay on top of [redacted] with his penis between [redacted] legs and performing a form of sexual intercourse until Slusher completed him ejaculation. [redacted] stated that he decided in July of 1975 that Slusher was doing him harm which resulted in him cutting off the relationship. Slusher became angry with [redacted] threatening him lest he told anyone about the sexual activity. [redacted] stated that Slusher ceased being friendly with him which [redacted] to affect his advancement in the scout troop. [redacted] further stated that in August of 1975 while on a scout camp out, a boy/scout troop by the name of [redacted] related to him that while he, [redacted], and Slusher were sleeping in the same tent, he witnessed Slusher masturbating [redacted]. [redacted] became frightened and left the tent meeting [redacted] relating the incident. [redacted] stated that almost all of the scouts in the scout troop knew that Slusher was a homosexual and that [redacted] was involved with Slusher sexually. Slusher on one occasion, informed [redacted] that when he was around 18 years old and involved in a scout activity in Germany, he was viewed performing sexual acts on a 12 year old Wisconsin boy. The activity resulted in Slusher being sent to his home in Arizona. Slusher identified this boy only by the first name of [redacted]. Further Slusher informed [redacted] that he recently lost his Air Force ROTC scholarship at the University of Colorado due to the incident in Germany. [redacted] stated that a friend of his, [redacted], also has experienced sexual relations with Slusher.

NATURE OF REPORT: R/O continuing investigation of case.

DETAILS: R/O took note that on February 3, after the apprehension of the suspect and after advisement of his rights per miranda, the suspect informed R/O of his past residence addresses.

Residence #1 - 735 S. 35th Street, Boulder, Colorado, since the second week of January, 1977 to present.

Residence #2 - 471 Ord Street, Boulder, Colorado, since September 1976 to second week of January, 1977.

Residence #3 - 1170 Judson, Boulder, Colorado, since September 1975 to September, 1976.

On 2/15/77, R/O held a conference with [redacted], age 11, DOB 10/3/65, residence address [redacted], Aurora, Colorado, phone number [redacted]. [redacted] stated that he has had three sexual encounters with the suspect. The first encounter was on September 12, 1976. The suspect transported, from Denver, him and [redacted]. All three subjects went hiking near the Flatirons in Boulder County, Colorado. The suspect brought with him a blanket which was laid on the ground near a hiking trail. The suspect gave reason for the hike was for sexual activity and he could not do this at his residence due to other persons being at that residence. [redacted] served as a look-out on the trail to warn of other people approaching the area. The suspect directed [redacted] to get undressed while Slusher himself removed his own clothing. Both subjects [redacted] on the blanket whereafter Slusher began to masturbate [redacted] while kissing [redacted] body. [redacted] then laid on top of [redacted] placing his erected penis between the legs of [redacted] and performed a form of sexual intercourse which resulted in Slusher ejaculating semen on the body of [redacted]. Slusher expressed a desire to perform fellatio on [redacted] but [redacted] refused. Slusher also expressed a desire for [redacted] to masturbate him but again [redacted] refused. After the form of intercourse, [redacted] got dressed and then exchanged positions with [redacted]. [redacted] stated that [redacted] informed him that Slusher sexually molested him basically the same way Slusher molested [redacted].

[redacted] stated that the second encounter with Slusher was on Sept. 26, 1976. [redacted] and [redacted] were transported to Boulder by Slusher which resulted in all subjects going to the residence of Slusher at 471 Ord Street. All of the three subjects got undressed and got into bed. Slusher directed [redacted] to sit on the floor with his back towards the bed so that he could not watch the sexual activity between Slusher and [redacted]. [redacted] sat on the floor for about 5 to 10 minutes reading pornographic material which Slusher gave to [redacted] to sexually arouse [redacted]. [redacted] stated that the lights were off during the sexual activity and that he could only hear the whispers of Slusher and [redacted] during their sexual activity. [redacted] and [redacted] then switched places. [redacted] stated that while in bed with Slusher, that Slusher grabbed hold of [redacted] penis and began to rub it in an up and down motion. Slusher had [redacted] kiss him while he was masturbating. Slusher then started to kiss [redacted] over his body. Slusher asked [redacted] to perform masturbation on him which [redacted] refused. Slusher then placed a sock over his erected penis and climbed on top of [redacted] placing his penis between [redacted] legs. [redacted] was laying on his back. Slusher began to perform a form of sexual intercourse. All three subjects got dressed resulting in Slusher taking the boys back home.

[redacted] stated that his third encounter with Slusher was one or about Dec. 10, 1976. [redacted] stated that on this date, that he and [redacted] spent the night with Slusher at Slusher's residence. On the evening of Dec. 10, Slusher flipped a coin to see who would perform sexual

activities with him first. [redacted] was chosen resulting in [redacted] falling asleep on the floor. In the bed, Slusher grabbed hold of [redacted] penis and performed masturbation on [redacted]. After Slusher kissed [redacted] several times, Slusher placed a sock onto his penis and performed a form of sexual intercourse on [redacted].

R/O held a conference with [redacted] which resulted in a change in [redacted] original statement as to dates of occurrences. In the affidavit, [redacted] related an incident which occurred on Sept. 12, 1976. This particular encounter actually occurred on Sept. 26, 1976. [redacted] confirmed [redacted] statement about the hiking incident which occurred on Sept. 12, 1976. [redacted] stated that he did become sexually involved with Slusher on that date and that the statement of [redacted] was correct. [redacted] stated that during the original interview he had forgotten about that particular incident during a hike near the flatirons in Boulder County.

[redacted] and [redacted] viewed the slides seized during the search warrant. Both subjects stated that the slides taken of them together and [redacted] alone were taken at Slusher's residence by Slusher on Sept. 26, 1976. Both subjects identified the Olympus camera seized during the search warrant as being the camera used by Slusher to take photographs of them nude. Both subjects identified the pronographic material given to them to read by Slusher with intent to sexually arouse them prior to and after sexual activity.

[redacted] stated that since he became sexually involved with Slusher, he could not sleep at night. However, he states that since the case has been investigated and he was no longer involved with Slusher, he has been able to sleep without disturbing dreams. [redacted] stated that he was afraid to talk with anyone about the encounters with Slusher prior to the conference this date. The boy left the conference feeling good about himself and relieved that the activity was over.

2/16/77 - R/O filed three additional sexual assault charges through the District Attorney's Office on Slusher reference the sexual assault with [redacted]

R/O took note of undeveloped film in the Olympus camera seized during the search warrant. R/O remanded the custody of the film from evidence storage to Ofc. Hemberger, Boulder Police Dept. photolab technician for processing.

NATURE OF REPORT: R/O continuing investigation on above case.

DETAILS: R/O held conference with [redacted], DOB 3/13/63, address [redacted] Boulder, Colorado, [redacted]. [redacted] stated that he has experienced several sexual experiences with the suspect. The suspect moved into [redacted] house as a border on or about 2/1/74. Approx. 2 weeks after the suspect moved in, he began to make sexual advances towards [redacted]. The first time was when the suspect and [redacted] went ice skating at the Flatirons Skating Rink in Boulder. The suspect asked [redacted] if he ever "nuded" around with other guys and asked him to try it with him. After they returned home, he directed [redacted] to take off his clothes while Slusher himself undressed. [redacted] was directed to sit on the suspects lap and to masturbate the suspect. The suspect in turn, masturbated [redacted]. The suspect kissed [redacted] a few times whereafter [redacted] left the room. [redacted] relates that on another occasion, he and the suspect went on a trip to the Sand Dunes in Southern Colorado on or about 3/20/74. Just prior to reaching their destination, the suspect parked the car in a secluded area to bed down for the night. The suspect climbed into [redacted] sleeping bag whereafter mutual masturbation occurred with the suspect kissing [redacted] several times. The suspect crawled on top of [redacted] in an attempt to perform sexual intercourse, however, [redacted] stated that he pushed Slusher off of him.

[redacted] relates that sometime in April of 1974, he, [redacted], and a third boy by the name of [redacted] were at [redacted] home with Slusher. All three boys were directed to undress while Slusher himself got undressed. [redacted] stated that Slusher masturbated all of them and in turn, [redacted] three masturbated Slusher.

The latest incident that [redacted] could remember was on or about May 25, 1974. The incident occurred while at [redacted] house in Slusher's bedroom. Slusher had [redacted] lay on the bed nude while Slusher himself undressed. After mutual masturbation, Slusher climbed on top of [redacted] while [redacted] was laying on his back with his legs extended. Slusher placed his erected penis between [redacted] legs and performed a form of sexual intercourse until Slusher ejaculated.

[redacted] stated that Slusher threatened that he would kill him if he told anyone about the sexual activity. [redacted] asked of Slusher how he would kill him whereafter Slusher responded by stating that he would put poison in his food.

Upon completion of [redacted] statement, R/O filed, through the District Attorney's Office, one count of sexual assault on a child, reference the on or about May 25, 1974 incident with [redacted] R/O further referred [redacted] to the Dept. of Social Services for counseling in that [redacted] appears to have been affected emotionally by his encounter with Slusher.

At this time, it should be noted that several attempts have been made to meet with [redacted] and his parents. The parents, however, are very reluctant in pursuing any type of conference whether it be through this agency or another. Mrs. [redacted] states that the suspect has been good to her son and that she does not desire to jeopardize the good relationship. It is R/O's feeling that the parents may in fact be directly or indirectly promoting a homosexual relationship between their son and the suspect. R/O referred the [redacted] family to the Dept. of Social Services for follow up. It is further R/O's feeling, which was conveyed to the Dept. of Social Services, that if Mr. and Mrs. [redacted] continue their efforts to thwart professional services [redacted] attitude in essence may warrant a child abuse/neglect investigation.

2/28/77 - R/O interviewed [redacted], DOB 1/17/63, [redacted], Boulder, Colorado, 994-1218.

[redacted] states that he met Slusher through [redacted]. Further Slusher was the scout master for [redacted] states that he has experienced several sexual encounters with the suspect starting in December of 1973. [redacted] remembers that while at [redacted] house, he and [redacted] were directed to undress in Slusher's room. Slusher asked [redacted] if he wanted to see what sperm looked like which resulted in [redacted] masturbating Slusher until Slusher ejaculated. [redacted] remembers Slusher on his hands and knees while on the bed and having [redacted] perform anal intercourse on Slusher. (R/O at this point in the interview sensed a degree of unwillingness in [redacted] to relate much more of the anal intercourse episode. R/O believes that [redacted] most probably was also involved in performing anal intercourse on Slusher). [redacted] stated that there were other sexual encounters with Slusher throughout 1974 and 1975. [redacted] stated that during the scout jamboree in Europe, July and August of 1975 Slusher sexually molested him many times. [redacted] began to assist Slusher during the jamboree which resulted in Slusher threatening to kill him and or leaving him behind in Europe. Upon the return to the United States, [redacted] decided to quit scouting to get away from Slusher.

Upon the completion of the interview, R/O, through the District Attorney's Office endorsed [redacted] as a witness. R/O further had [redacted] endorsed as a witness.

2/27 - R/O interviewed [redacted], DOB 10/27/64, residence address, [redacted], Boulder, Colorado, [redacted].

[redacted] is a scout in troop 73, Slu-sheer being his scout master. [redacted] relates that Slusher began sexual approaches towards him in December of 1976, while in his company at the CU recreation center. Slusher would talk about sex and kiss [redacted] several times. In mid-January, 1977, while camped in a Rollinsville, Colorado area on a boyscout camp out, Slusher arranged to sleep with [redacted] in the same tent. Several attempts were made by Slusher to have [redacted] undress and crawl into Slushers sleeping bag. [redacted] stated that he was scared of what would happen if he got into Slusher's sleeping bag and refused. Slusher offered [redacted] money and special attention if [redacted] would sleep with him nude. [redacted] stated that Slusher made an attempt to hypnotize him to see if [redacted] would make it easier for him to sleep with him. [redacted] stated that he told Slusher that he would get into Slushers sleeping bag in the morning after they woke up with hopes of Slusher forgetting about it. Slusher agreed. The next morning, Slusher reminded [redacted] of his promise and [redacted] again refused stating that too many scouts were up and around resulting in someone probably hearing them.

After the completion of the interview, it was obvious that [redacted] had been placed under extreme emotional pressure to become sexually involved with Slusher. It was a matter of time before the [redacted] was either seduced or informing his parents of the problem. R/O would seek endorsing [redacted] as a witness through the District Attorney's Office.

R/O was informed by Photo-technician Hemberger that the film processed on 2/16/77 was developed and had no bearing on the case.

[redacted] R/O has been unable to identify the photo slide of one nude juvenile male which was seized during the search warrant of Slusher's residence.

# Former Scout Leader Pleads Guilty To Sexual Assault On Child Charge

A former Boy Scout troop leader with a 3.7 grade average in chemical engineering at the University of Colorado pleaded guilty to one of eight charges of sexual assault on a child in District Court Thursday.

Floyd David Slusher, 24, 75 S. 35th St., faces up to 10 years in prison and a fine of up to \$30,000 when he is sentenced Sept. 12.

Or he could be sentenced under the state's sex offender's act, which would commit him to the state Department of Institutions for one day to the rest of his life.

Slusher was accused of forcing sexual contact on several young boys ranging in ages from 10 to 14. He met them through his scouting activities between July, 1975 and last January. He was arrested on four charges in February, and five additional charges were filed after his arrest. One of those charges was dismissed because it was outside the court's jurisdiction.

In several instances, according to court records, Slusher would pick up a youth at home with an excuse that he was taking the boy to a movie or a Boy Scout function, and instead would take the youth to his Boulder apartment, where most of the alleged sexual assaults occurred.

According to court records and meetings with the District Attorney, Slusher never really threatened the boys to engage in sexual activities, but threatened violence to the boys if they told anyone about the incidents.

Slusher came under investigation after one of the boys' parents reported to a Boulder County Sheriff's officer that he was suspicious of Slusher. After one youth admitted to sexual activities with Slusher, several others were interviewed and admitted to the

activities.

Some, according to court records, occurred at a Boy Scout summer camp in Larimer County last summer. Slusher then continued his acquaintance with the boys during the fall and summer.

The charge he pleaded guilty to accused Slusher of forcing sexual contact on a 12-year-old Aurora boy. That same youth was named as victim in three other charges, one of which occurred after Slusher got the youth drunk on vodka at Slusher's apartment, according to court records.

District Attorney Alex Hunter said Thursday's guilty plea was entered as a result of lengthy sessions with the other boys and their families. Hunter said that some of the parents did not agree with the disposition.

The boys and their parents met with Hunter at the DA's office Monday afternoon. The conversation centered on the propriety of plea bargaining in the case. Parents were concerned that if Slusher is charged with eight counts of sexual assault on a child, he should be held accountable for all eight charges.

But Hunter explained then, and again in court Thursday, that Slusher's guilty plea to only one of the charges subjects him to the same penalties he would have received had he gone to trial and been convicted of all eight counts.

Some parents were not satisfied with last Monday's discussion, and asked Judge Rex Scott, who will sentence Slusher, if they could speak to him. Scott refused the request, however, saying Thursday it is unethical for a judge to discuss a pending case.

Scott recommended the parents contact the probation department for comments on Slusher's sentencing.

One of the boys at last Monday's session in the DA's

office said he was disturbed by Slusher's ability to plead guilty to only one charge.

"We think you should use all eight charges to make him feel as bad as possible — to make him feel as bad as we felt," the youth told Hunter.

Many of the other boys and their parents agreed.

Hunter told the families that if they do not agree with the negotiated plea, they have the ability to file in District Court a motion for the DA to compel prosecution on any or all of the eight charges.

But, Hunter pointed out, Slusher's entry of a guilty plea saved the time and expense of a lengthy trial on the charges.

At Thursday's hearing, Slusher stated that the reason he decided to plead guilty was to avoid going to trial.

Born Feb. 27, 1953 in Geneva, N.Y., Slusher was reportedly accepted at more than 30 major universities in the United States. He was a member of the ROTC drill team at CU, was photographer, assistant editor and later editor-in-chief of the "Colorado Engineer" (a magazine), and reportedly received four full scholarships to American universities.

He also reportedly received an appointment to the Air Force Academy in Colorado Springs in 1972, but turned the offer down. He also taught various religious classes at a local church.

When he was released on \$20,000 bond several months ago, a number of CU professors testified in his behalf. Several well-known attorneys in Boulder who could not be present at the bond hearing sent letters to the court recommending Slusher's release on bond.

The negotiated plea, Hunter said at last Monday's meeting, is a classic example of attempting to balance what is best for the defendant, the community and the victims.




