
Dear Sirs:

The Scoutmaster, Mr. Rupert Baird, has been admitted to a mental institution.

Mr. Hilts is still in Albany and will not be registered here, however, he may not be permanent here and we would like to have his name added to your confidential list to prevent his registration elsewhere.

Mr. Hilts is single, about 24 years old and is presently residing in a boarding house on Pine Avenue in Albany.
