THIS MATTER having come on regularly for hearing before the above-entitled court upon the petition of JAMES M. DORAN, Deputy Prosecuting Attorney for Whatcom County, Washington and the said ARTHUR HOWARD DOWNING, Jr. III, being present and represented by his counsel, JAMES G. BELL, and the Court having examined the petition, and having considered the files and records herein, and the defendant having waived the statutory requirement of medical testimony by two duly licensed physicians, and the Court finding that there is reasonable ground to believe that the said ARTHUR HOWARD DOWNING, Jr. III is a sexual psychopath; now, therefore,

IT IS ORDERED that the said ARTHUR HOWARD DOWNING, Jr. III be confined at Western State Hospital for observation as to the existence of sexual psychopathy for a period not to exceed ninety days, and the defendant shall be returned to the Whatcom County Jail within ninety days until further order of this court; and a psychiatric evaluation and report shall be submitted to this court.

IT IS FURTHER ORDERED that the said ARTHUR HOWARD DOWNING Jr. III to remain free on his personal recogni^{zance}-/pending execution of this observation order by the Department of Social and Health Services and be returned





PLEA OF GUILTY

1. My true name is ARTHUR HOWARD DOWNING, JR. III
2. My age is 38
3. My lawyer is JAMES G. BELL
4. The court has told me that I am charged with the crime of SODOMY

The maximum sentence for which is 20 years per count

5. The court has told me that:
 - a. I have the right to have counsel (a lawyer), and that if I cannot afford to pay for counsel, one will be provided at no expense to me.
 - b. I have the right to a trial by jury.
 - c. I have the right to hear and question witnesses who testify against me.
 - d. I have the right to have witnesses testify for me. These witnesses can be made to appear at no expense to me.
 - e. The charge must be proven beyond a reasonable doubt.

6. I plead GUILTY to the crime of SODOMY; COUNTS 1 & 2

7. I make this plea freely and voluntarily.
8. No one has threatened harm of any kind to me or to any other person to cause me to make this plea.
9. No person has made promises of any kind to cause me to enter this plea except as set forth in this statement.

10. I have been told the Prosecuting Attorney will take the following action and make the following recommendation to the court:

After observation at Western State Hospital -- If found to be a sexual psychopath and treatable, that he be given a 5 year deferred sentence on the condition that he be on probation for 5 years, remain with the Department of Institutions at Western State Hospital until such time as he is no longer a sexual psychopath OR IN THE ALTERNATIVE if he is found not to be a sexual psychopath ~~but~~ not amenable to treatment, the recommendation is the Department of Institutions.

12. The court has told me that if I am sentenced to prison the Judge must sentence me to the maximum term required by the law, which in this case is 30 years per count

The minimum term of sentence is set by the Board of Prison Terms and Paroles. The Judge and Prosecuting Attorney may recommend a minimum sentence to the Board but the Board does not have to follow their recommendation. I have been further advised that the crime with which I am charged carries a mandatory minimum of _____

(If not applicable, this sentence shall be stricken and initialed by the defendant and the Judge.)

13. The court has asked me to state briefly in my own words what I did that resulted in my being charged with the crime in the information. This is my statement:

In the evening, on or about the last Friday in Feb. 1974 I submitted to allow [redacted] to use my body sexually by way of Anna and then I did the same to him.

Two or three weeks later sometime in March 1974 this same thing happened again with me doing it first to [redacted] and then he returned did it to me.



NOVEMBER 5 - 1974

JAILED - A man who faces three sodomy charges in Whatcom County Superior Court has been given a 90 day jail sentence in district court for the possession of marijuana. The sentence was meted out by Judge Leslie

Lee after Art Downing, 38, 437 D St., Blaine, pleaded innocent to the charge.

An appeal bond of \$300 was established after Downing indicated he intended to appeal the decision.

He is currently on sentence.

APPEALS DECISION-Arthur Howard Downing, 38, 437 D St., has appealed a Nov. 4 decision in Whatcom County District court finding him guilty of possession of marijuana. Judge Leslie A. Lee sentenced him to 90 days in jail.

An appeal bond of \$300 has been established.

12-22-74

TO BE EXAMINED-A man accused of sodomy will receive a thorough psychiatric examination at Western State Hospital.

Arthur Howard Downing, 38, Blaine, and his attorney waived the requirement that two local psychiatrists make an examination prior to such action being taken.

Judge Swedberg refused to order a similar procedure for Joel Peter Keiper, 19, 1714 12th St., charged with indecent exposure. On Nov. 27, a jury was unable to reach a verdict in his case.

Judge Swedberg told Deputy Prosecutor Doran to prepare an affidavit stating the reasons why an examination for possible sexual psychopathy is warranted. The matter will be considered again in two weeks.
