patient, is a scout and member of the Order of the Dr. Arrow. is 20 years old, retarded with the mentality of a 12 year old.

a longtime patient of Dr. wished to sever a relationship causing him serious distress, revealed to Dr. a series of homosexual acts forced on him by Arthur C. Carmean, Executive Trainee. Dr. conveyed this message to me and suggested I investing the matter as soon as possible.

March 29, 1974 - approximately 9:35 1.M.

Made contact with Dr. for details from which to start investigation. reported the homosexual acts began in August 1973 at Comp Gerber during an O. A. weekend and continued to December. He reported some eight incidents, involving money, an are and a shotgum.

March 29, 1974 - approximately 10:30 A.M.

In a 2 1/2 hour meeting with Carmean, where he was confronted with the accusations, he admitted to performing homosexual acts at camp. His resignation was requested immediately with strong suggestion that he seek psychiatric help. He was also warned to stay away from sodomy suit would be brought against him if there was any reoccurance.
