

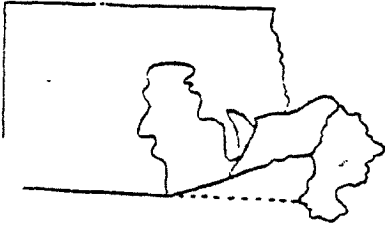

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a B.S.A. Leader should be granted or reinstated.
