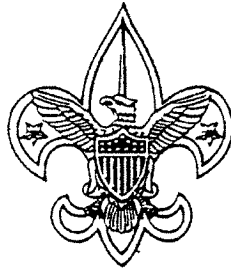

Dear Sir:

Today Mr. Bill Post, District Commissioner, from Reidsville, N.C., and I hand delivered the enclosed letter (A) to Mr. William Fisher.

Mr. Fisher read the letter in our presence. He apologized for his actions and the possibility that his actions could hurt Scouting.

He stated that he is presently undergoing treatment to correct his behavior by a Dr. Willis in Greensboro, N.C. He stated that his next appointment is tomorrow morning at 11:00 a.m. Mr. Fisher stated that he did not desire to have the decision reviewed. He did state that he hoped that at some point in the future he might be allowed to serve in Scouting again, possibly at the district level.

We informed him that after a period of time and with written certification from a qualified person that he may again be reinstated.

Mr. Post and I shook hands with Mr. Fisher and left.

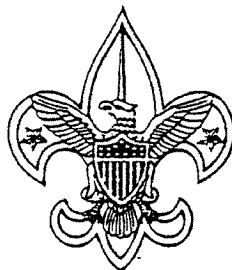

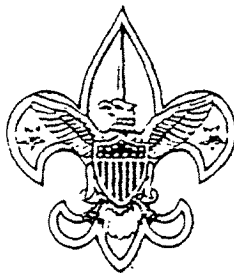

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA Leader should be reinstated.

This letter is to confirm the conversation my wife and I had with you, Bill Post, Jim Fish and Raymond Wagoner.

I can at this time only relate to you what our son [REDACTED] is able to talk about. He is still under the care of Dr. John Edwards and is not yet able to reveal everything that happened.

[REDACTED] told us that Bill Fisher asked him to get in bed with him because it was cold and the heat was turned down. After he kissed him on the lips and told him good night, [REDACTED] began to go to sleep. [REDACTED] said he felt his underpants being pulled down and Bill's hand began rubbing his buttocks. [REDACTED] felt peculiar, but did not know exactly what to do, except hoping that he would quit. After a time he felt Bill's hand go between his legs and began to fill his genitals. [REDACTED] began to fill panic, but was afraid to move or say anything. After a time Bill pulled down his underpants and lay on top of [REDACTED]. [REDACTED] felt terrified and just wished Bill would get off of him.

It is at this point that [REDACTED] is not able to recall exactly what all did take place, except that after a time Bill got off from on top of him and asked him if he was still cold.

The above incident took place around the 1st of October, 1980. We began to notice a change in [REDACTED] and his teacher called my wife to come to school for a conference. The teacher, Miss Jones said she had seen a drastic change in [REDACTED] grades and in his attitude. She said that he just did not seem to care.

We could see [REDACTED] began to deteriorate and we tried to ask him what was wrong, but every time he would begin to cry.

In January we took [REDACTED] to Dr. John Edwards (a clinical psychologist) in Greensboro, N. C.

We began to see some improvement in [REDACTED] but not considerable.

On March 11, 1981 Bill Fisher (Bill was a personal friend of the family. He lived with us for three or four weeks when he moved out from his mother's house until the trailer that he had rented was empty. He usually ate supper with us three or four times a week and would pick the boys [REDACTED] up after school and bring them home. He had a key to our house in case the boys forgot or lost their key or if he needed to borrow something.) asked [REDACTED] if he wanted to spend the night with

him, But [redacted] did not want to go. My wife saw the expression on [redacted]'s face when Bill asked him to spend the night with him and she knew something was wrong. My wife took [redacted] into another room after Bill had left and began asking him questions. [redacted] began to cry and did not want to talk, but my wife kept on prying until he finally broke and told us what had happened. At first [redacted] would only say that Bill pulled down his underpants and layed on top of him.

[redacted] said he felt guilty, that maybe he had done something to make Bill do this to him. [redacted] felt like he was the only boy this had ever happened too.

On March 13, 1981 we asked Bill Fisher to come by our house, that we wanted to talk to him. When Bill arrived we had our minister, Reverend [redacted] Jr. there with us. We confronted Bill and he admitted that he had molested him.

The above description is to the best of my knowledge what transpired.

Mr. Raymond Wagoner was by my study today and this letter is being written to you by his request.

You are already familiar with the matter regarding Mr. Bill Fisher and Mr. and Mrs. [REDACTED] and their son [REDACTED]. After talking with Mr. Wagoner I feel the information Mr. and Mrs. [REDACTED] gave you is correct to the best of my remembrance.

Briefly, Mrs. [REDACTED] asked me to come to their home on the night she and Mr. [REDACTED] were to have Mr. Fisher come over to confront him with what she had learned from her son, [REDACTED]. I was there when Mr. Fisher arrived. After a brief greeting Mrs. [REDACTED] confronted Mr. Fisher with the matter of her son [REDACTED] problem giving him (Mr. Fisher) every opportunity to tell her what had happened in the past to trigger the trouble [REDACTED] had described. Mr. Fisher was reluctant to talk and tried to suggest he knew nothing about what she was referring to. Whereupon, Mr. [REDACTED] told him in so many words to come off it she and her husband knew what he had done and he needed to tell his side of the matter. When Mr. Fisher was still reluctant to talk about it she told him what her son had told her. Mr. Fisher wanted to deny it but found he could not easily do that. He said if I did do that I don't remember it. Mr. [REDACTED] again pursued the matter and would not let that reply stand. She said she did not believe that. Slowly and reluctantly Mr. Fisher admitted there had been indecent liberties taken. The family then urged him to seek help. Mr. Fisher agreed to talk with me. He did this twice and then called one day to say he could not keep a third appointment. I have seen him only once since that time when he came to a special Scout Service at the Church (when Chuck Jones got his Eagle Award).

I heard that Mr. Fisher had seen a doctor in Greensboro once. Then I heard again he had been twice. All of this is hearsay.

I do not know if this is of any value to you. If you have further questions I will do my best to answer them. Of course you will understand and appreciate that I cannot divulge anything said in our counselling times. I would not betray a trust if I can help it.

It is with a great deal of shame and anxiety that I must write you this letter. The events related to you concerning my contact with [REDACTED] are essentially correct.

[REDACTED] had spent a number of nights in my home last fall. In November (late November, as I recall) he climbed into my bed before going to his own. I did feel his fingers.

There was no kissing. There was no genital contact.

[REDACTED] left my room after about five minutes and went to his own bed.

This was the only occasion on which any contact out of the ordinary occurred between us.

I regret — deeply — that this happened. I know that saying I'm sorry changes nothing. But I do want you to know anyway.

At the suggestion of [redacted] parents I have had two sessions with a Dr. Willis of Greensboro. He suggested that I fulfill my commitment to Camp Old Indian, and gave me his phone number in case any problems should arise. None have arisen.

I have resigned as Scoutmaster of Troop 749, effective today. This action I offered to take in March. Mr. and Mrs. [redacted] at that time (which was after they discovered the event with [redacted]) did not wish me to resign.

I am committed to continue to seek professional help. It is my hope that, through this help, I will someday again be able to be of service to Scouting. Scouting has been wonderful to me and knowing that I have harmed it is one of the worst feelings of my entire life.
