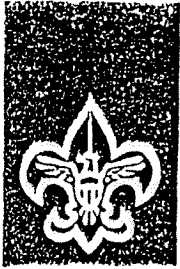

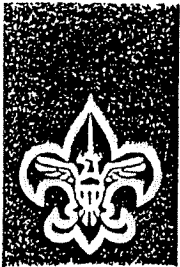

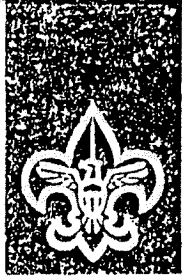

CONFIDENTIAL MEMO FOR FILES

SUBJECT: Confidential investigation of Scoutmaster [redacted], sponsored by the [redacted], in [redacted], California.

On July 28, 1981, [redacted], the District Chairman of the South Bay District, and I met with [redacted]. [redacted] is a former member of [redacted], sponsored by the [redacted]. At that time the Scoutmaster was [redacted]. His Assistant Scoutmaster was [redacted]. In followup from several inquiries from parents, [redacted] found out that the Scoutmaster [redacted] had made advances to several of the boys on camping trips. [redacted] confronted [redacted] with this information, the result being that [redacted] moved from the Scoutmastership in [redacted] to form his own new [redacted], sponsored by the [redacted] in [redacted]. This action occurred in approximately [redacted] of [redacted]. [redacted] called the council office to reveal the information he had to date. This information was shared with Ted Hanley, and Ted had a discussion with [redacted] and with [redacted] the District Commissioner of the South Bay District.

In conversation with [redacted] at his home in [redacted] the following statements were made by [redacted]: [redacted] indicated that he had been a member of [redacted] in [redacted] approximately 3 years ago. On a campout trip [redacted] invited [redacted] to share his tent with him. At nighttime as they were getting ready for bed [redacted] was in a playful mood and was shoving and grabbing, etc. This progressed to one point where [redacted] put his hand inside [redacted] sleeping bag. [redacted] relates at this point he was beginning to get worried, scared and to realize that something was wrong, and that he yelled in a loud voice "stop it, you faggot". The Scoutmaster, [redacted] then exposed himself to [redacted]. Although no further incidents happened that night, the next night [redacted] was not invited to share the tent again with [redacted].

[redacted] indicated that on numerous occasions [redacted] had been very reckless in driving while boys were in the truck, in speeds of 90 to 100 miles per hour on the freeway. [redacted] stated that [redacted] gets along well with the younger boys, but the boys over 12 hate him.

[redacted] related an incident involving the troop when 10 Scouts in [redacted] truck drove to a Merit Badge Day held at [redacted]. Three of the boys, [redacted], [redacted] and [redacted] were abandoned at the site by [redacted]. All three were standing by the truck as [redacted] prepared to leave and were told that he was not happy with their performance at the Merit Badge Day, and drove off without them. [redacted] was forced to call his Dad so that they could provide transportation back to their homes.

[redacted] indicated that it was widespread knowledge among the older boys in the troop that [redacted] made advances to several of the boys. His pattern was always to invite the boy to share his tent with him.

[redacted] told of another incident related to him by one of the Scouts on a trip, that he, [redacted], had not attended. Five of the best Scouts in the troop selected by [redacted], were invited on a trip to Wyoming, Las Vegas and Canada. It was a two-week trip. [redacted], a Scout in the troop, woke up one night to find [redacted] hand in his sleeping bag.

He talked about another troop state-wide trip to Las Vegas, where [redacted] pulled a camper behind his truck, and three of the boys were locked out of their camper until 3 a.m. in the morning because [redacted] had gone into town and left the boys by themselves.

[redacted] stated it was common knowledge among the older boys and the Scouts that there has been several advances made on camping trips. In one case a boy was invited to go to a movie with [redacted].

Following our interview with [redacted] Frank [redacted] and I discussed the matter and decided that our procedure should be to submit a letter signed by the Scout Executive requesting that [redacted] not continue his registered leadership status with the Boy Scouts of America. We agreed that we would deliver this letter asking [redacted] to join us at the first available date. I indicated to [redacted] that our recommended procedures suggest that such a letter should be hand delivered but that no accusations should be made whatsoever.
