SUBJECT: Craig D. Hartley, Former Scoutmaster of Troop 36 in Los Altos

Age: 30 (approximation as of December 31, 1979)

About two weeks ago, I received a telephone call from Chief of the Los Altos Police Department. He said that he had a group of parents who had boys in Troop 36 in his office. These parents were making a complaint about Hartley. He said they had uncovered the fact that Hartley had committed inmoral acts with the Scouts including fondling them. After discussing the legal requirements of prosecuting Hartley, the parents had decided not to prosecute in order to avoid embarassing their sons. However, they wanted Hartley to resign and not to ever be associated with Scouting again.

I immediately contacted Troop 36 Committee Chairman, Albert Jacobson. He said that he was aware of the problem and that Hartley had been removed as Scoutmaster. We made an appointment and several days later we discussed what needed to be done to make sure Hartley would no longer have any contact with Scouts.

Mr. Jacobsen assured me he would follow up and let me know if he had any problems. I then made a verbal report to you, removed Hartley's mailing plate, eliminated his name from the Troop 36 active adult member roster and informed members of the staff that Hartley was no longer an active Scouter and should not be allowed to participate in any part of the program.


