- 1/2 District Executive met with the Committee Chairman and the Scoutmaster.

- 12/29-31 Brian MacDonald invited four Scouts to camp for the weekend to work on badges which was unknown to the Scoutmaster and the Committee.
- 12/31 The father of one of the boys contacted the Scoutmaster and related a story of "sexual harassment" to the boys over the weekend.
- Upon advise of a Priest, the Scoutmaster met with Brian and told him of the boys stories. According to the Scoutmaster, Brian was visibly upset and admitted to some of the boys statements. He agreed to resign from the Troop as requested by the Scoutmaster.
- 1/1 The Scoutmaster talked to all four boys involved as well as several other boys currently with the troop and some past members. Similar stories were given by all four boys who had camped over, as well as by several other members on previous occasions.

1/3 District Executive, Scoutmaster, Committee Chairman and Brian met. Scoutmaster related all the knowledge that had uncovered. Again, MacDonald, upset, willingly signed the enclosed resignation as requested by the Scoutmaster and agreed to seek professional help; while admitting to some of the actions.

Moby Dick Council notified.

To date - no further actions taken by anyone involved.
