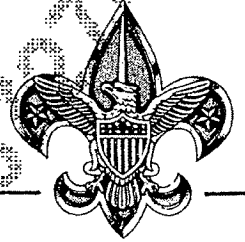

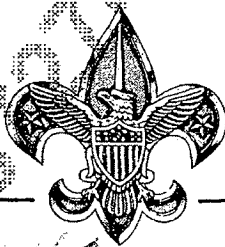

But this letter has to do with one of those unpleasant duties we must act upon once in a while. I have just been given the following report from District Executive Dwaine E. Gipe:

"I met with Rev. [redacted] minister of Calvary Methodist Church, Sponsor of our Troop 6. He informed me that Scoutmaster Joseph S. Ettwein had five or six direct complaints upon his actions with the boys of Troop 6.

One father assured the pastor that he would testify to the church board if necessary concerning perversion.

The minister consulted with Joseph Ettwein on the situation and within a day or two the Scoutmaster resigned.

The minister is working with the situation on a counseling basis and hopes he may be of some valid assistance."
