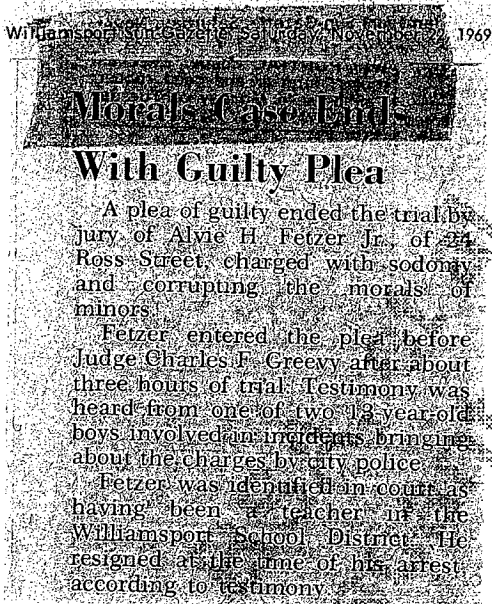

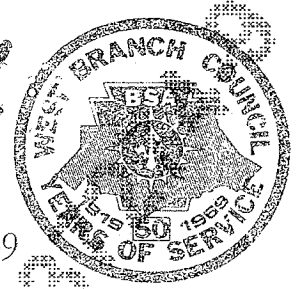

Sun Gazette - Tues 21 OCT 69 Man Charged With Morals Offenses

Alvie H. Fetzer Jr., 27, of 24 Ross Street, was charged before Police Magistrate James T. Nesbitt today with sodomy and corrupting the morals of a 14-year-old boy.

Fetzer was charged by juvenile authorities after incidents which allegedly occurred on May 28, June 7 and June 20, in Fetzer's apartment on Washington Boulevard.

Fetzer was committed to the County Prison in default of \$2,000 bail for a hearing at 9:30 a.m. next Tuesday.

On Sept. 26, Fetzer was arrested on similar charges allegedly involving a 12-year-old boy. He posted \$1,000 bail on that count and waived hearing.

Man, 26, Arrested On Morals Charge

Alvie H. Fetzer Jr., 26, of 24 Ross Street, was arrested yesterday by city police on two morals charges. They involved a 12-year-old boy, police said.

Fetzer was arraigned before Police Magistrate James T. Nesbitt on charges of sodomy and corrupting the morals of the boy. He posted \$1,000 bail, and waived hearing for court.

According to police, the boy was in Fetzer's apartment on three occasions: May 19, June 2 and June 4.

Mr. Alvie H. Fetzer, Jr. is currently registered as Scoutmaster In troop 171, sponsored by the East End Baptist Church in Williamsport, Pennsylvania, Eastern District (#1), West Branch Council (#543).
