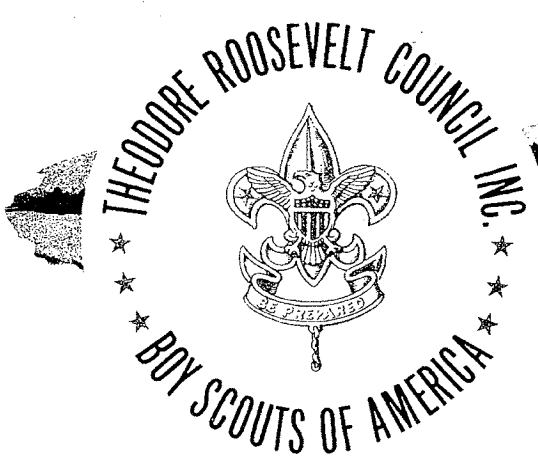



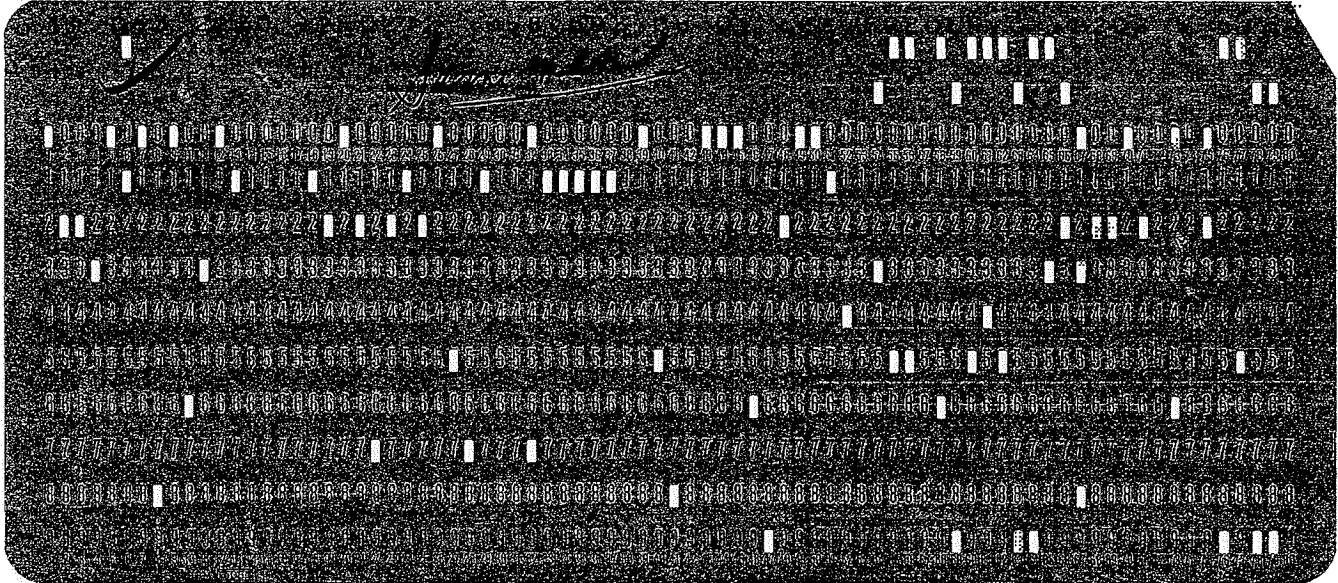

We are herewith enclosing a credit notice of \$2.00. Please delete Mr. Frederick's name from your records.

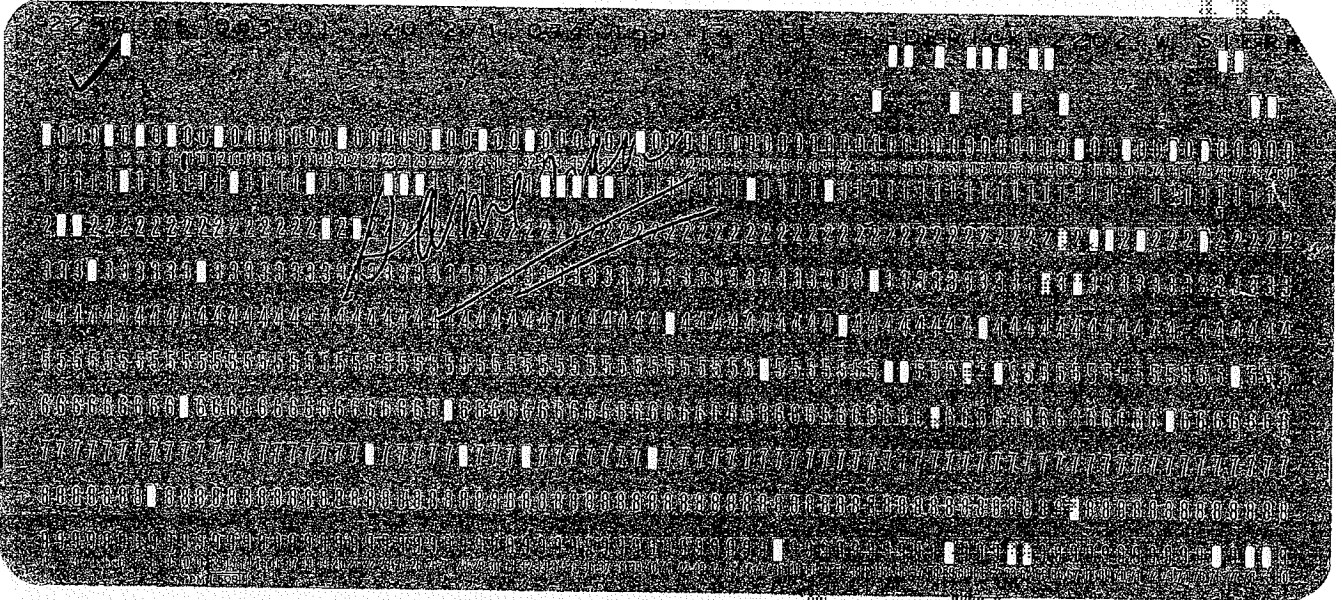
