Your letter of June 28, 1988, regarding the issuance of a Life Membership in NESA to Donald Fricke who is on the Confidential File is appreciated.

Attached is my notice to Mr. Fricke that we are denying him membership in NESA and returning his \$150.00 fee.

I have placed the NESA file on the computer main frame. However at this point, the Information Systems Division has not cross referenced it with the Confidential File. Since the NESA file contains over 100,000 entries, it is not possible to hand check it against the Confidential File.

It is my understanding that I.S.D. is currently working on this situation toward the end that we will be able to cross reference prior to the issuance of NESA membership credentials. All of us are aware that cross referencing is appropriate.

It has never been a requirement that a NESA member be registered with the Boy Scouts of America. We do not believe it should be but strongly support the cross referencing approach.

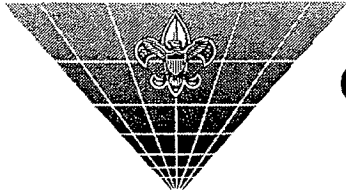


I guess the question is this:

# Scout leader's ouster draws mixed reaction

MILFORD — A recent decision to banish a Boy Scout leader, convicted 18 years ago of molesting a teen-ager, has sparked a public outcry among some parents and Scouts who know the man. But others applauded the ouster.

Donald Fricke, 41, of Milford, was convicted in 1966 of fondling a Boy Scout when he was a Scoutmaster at Old Settler's Boy Scout Camp in Milford, court records say. The Quinnipiac Council asked for Fricke's resignation after learning of his criminal record two weeks ago.

Shirley Ellis, the mother of a Boy Scout in the Order of the Arrow, chastised the Boys Scouts of America for removing Fricke from the organization, and criticized the newspapers' account of the dismissal. Fricke worked with the boys in the Order of the Arrow, a Scouting honor program.

"Don told me the Scouting association lawyers said they would back him 100 percent," she said. "The parents were behind him 100 percent."

Ellis, of Milford, said she does not want her sons in an organization that goes back on its word. But one of her sons plans to remain a member, she added.

Ellis said Fricke always had provided encouragement for her son.

"My son came home in tears. Whoever is doing this is ruining him (Fricke)," she said.

She also chastised the newspaper's illustration of a Boy Scout hovering beneath a shadowy figure, saying she does not want her children to see it. "I think they'd be afraid because of the picture," she said.

Ellis said she is worried Fricke,

who is a maintenance worker for the city, will lose his job as a result of the publicity.

But she doubted other parents would push for his reinstatement.

"When it comes down to it, everyone says they are behind him, but no one wants to get involved," he said.

Her husband, Ernest Ellis Sr. agreed.

"Most people are too lazy," he said.

He commended Fricke's accomplishments in Boy Scouts.

"He has given his all to Scouting," he said. "He has done a lot of good for the kids in the city."

Ernest Ellis said it is unfair to make Fricke pay for a crime he committed years ago.

"This individual has made a complete about-face," he said. "You are now trying him again 19 years later."

"There are so many bad people out there, but you pick the tops," he added.

Boy Scout District Commissioner Rita Burke of West Haven,

however, characterized Fricke's banishment as just.

"I feel a bank robber gets a second chance, but I have seven kids," she said. "I'd like to lead the group of mothers who go after this guy or someone like him."

She praised the newspaper stories about Fricke and the screening process of volunteer organizations.

"If they (reporters) have facts, I want to see it blazed in the paper," she said. "And, I honestly feel there should be more scrutiny (in selecting volunteers)."

Edward Quirk, whose son is a member of the Order of the Arrow, also said the council correctly removed Fricke.

"His leadership makes parents question other leaders," he said. "Once convicted, a rule is a rule. He should not be in a responsible position with boys."

Quirk said the story probably never would have surfaced if the council had dealt with the problem.

"If the council leadership can't clean its own house, then the news-

paper has an obligation to print the story," he said. "If they had knowledge before your contacting them, they should have dealt with it instead of sweeping it under the rug."

Jane Platt, a parent of a Milford Boy Scout, said she has mixed feelings about the ouster. Fricke should be given another chance, she said, but she realizes that move would leave parents wondering whether there are other Scouting leaders with similar records.

She said the newspaper stories smacked of "muckraking," but that does not mean they should have been suppressed. She also faulted the story for having no real basis, since there was no current danger.

Richard Burdick of West Haven said the council should have handled the incident in confidence.

"I think both articles were untimely," he said, noting Boy Scouts of America celebrates its 75th anniversary Friday.

"It's Scouting week," said Burdick, a member of the Order of the Arrow. "This kind of gives them a black eye."

He accused the newspaper of sensationalizing the story.

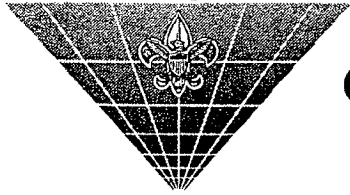
"I don't think it's right," he said. "It's like a boy stealing a candy bar . . . x-amount of years ago . . . and there has been no repetition."

Two young members of the Order, Thomas Trower of Hamden and Michael Harold of Milford, said Fricke deserves a second chance.

"I think kids can have trust in him," Trower said. "But parents may not have trust in him."

Kenneth Prowse, council executive of the Quinnipiac Council in Hamden, refused to comment.

Report and Recommendation Concerning Donald Fricke

This report and recommendation have been prepared and submitted in response to a letter of February 19, 1985 from Mr. Donald Fricke to Mr. Kenneth W. Prowse, Scout Executive, requesting reinstatement as a Scouter. On January 25, 1985, following publication of an article in the New Haven Register concerning Mr. Fricke's conviction in 1966 for alleged child molestation, Mr. Fricke tendered his resignation from the Boy Scout movement. The letter admitted that "a very costly mistake was made". The resignation was accepted and acted upon.

A registration review committee was appointed by the President of the Quinnipiac Council. The review committee met with the Council president and the Scout Executive to review what materials had been received relating to the matter. These included the newspaper story; Mr. Fricke's letter of resignation and letter seeking reinstatement; a further letter to Mr. Prowse from Mr. Fricke dated February 28, 1985; letters from the Arcoon Lodge, of February 15, 1985, supporting his reinstatement; letters from Mr. Ernest Ellis, Jr. and Mr. and Mrs. Ernest Ellis; a letter of April 11, 1985 from Betty Brosius also supporting Mr. Fricke's reinstatement, and an anonymous letter of February 8, 1985

containing certain allegations of misconduct by Mr. Fricke. The latter letter was disregarded in view of the fact that it was not signed. The committee, through one of its members, made further inquiry of Mr. Stephen Schiller and Mr. Edward Quirk, Jr.

The committee, at its invitation, met with Mr. Fricke on May 28, 1985. Mr. Fricke told the committee that he had in fact signed a statement at the police station in connection with his 1966 arrest and subsequent conviction. He offered certain facts in mitigation. In answer to questions from the committee, Mr. Fricke agreed that he had worn clerical garb, as had been reported to the committee, but he stated that he was authorized by the Capuchin Order to wear such garb although neither a Roman Catholic nor a member of that Order. Inquiry of the Capuchin Friars at St. Pius X Church in Middletown, Connecticut disclosed that lay persons are not authorized to wear the external attire of the Order.

The committee discussed with Mr. Fricke not simply the matter of wearing clerical garb but many of the other items raised in the letters and in his explanation and presentation. It reviewed as well his career and accomplishments in Scouting.

It is the conclusion of the committee, based upon the results of its examination, that Mr. Fricke should not be reinstated as a Scouter. The fact that his representation to the committee proved untrue should in and of itself demonstrate that he does not possess the requisite qualities to afford positive leadership to youth.

While he has contributed to Scouting over the years and may well be a decent citizen, it is the conclusion of the committee that he does not meet the standards of leadership required by Scouting.

# Red tape snarls groups' efforts to clear ranks of child molesters

He or she could be a Sunday School teacher, Scout leader, day-care supervisor, Little League manager or counselor.

A child molester.

Each year, reports abound of molesters infiltrating volunteer organizations, preying on defenseless boys and girls. The problem has forced parents to

take a second look at the people to whom they always have entrusted their children's care. And, it has compelled the organizations to enforce stringent screening policies.

Representatives of volunteer organizations say reports of perverts targeting their children crop up each year, but while there is cause for alarm, the problem is not of crisis proportions. Organizations like Big Brothers-Big Sisters, Boy Scouts of America, and Girl Scouts of the United States of America each tackle the problem differently.

Big Brothers-Big Sisters of America, for example, is pushing legislation permitting national police checks on the background of its volunteers, said Donald Wolff, vice president of

Big Brothers-Big Sister programs.

In a telephone interview from his St. Louis office, Wolff said he has gained the assistance of [redacted] whose story about the kidnapping and decapitation of his son [redacted] became the subject of a television documentary. [redacted] story provided an impetus behind an ongoing movement to find missing youngsters. His father represents the National Center for Missing and Exploited Children.

Wolff said [redacted] has agreed to include the proposed background check in a legislative package protecting missing children. [redacted] is lobbying for the package in Congress, while Wolff prepares a model bill—allowing background checks—to be presented to each state legislature. He said he doubts Congress will pass the legislation.

"It costs money to have a central collection area," he said. "Nobody wants to take the time or trouble. They feel it should be left up to the states. That's the fractionalization of the problem."

Some states allow Big Brothers-Big Sisters agencies to run police checks, he said, but the investigation is illegal in other states. And, some states prohibit the use of the National Crim

# Scout records fail to ferret out offender

MILFORD — The Boy Scouts of America has banished a leader who last year received one of its highest honors after learning the man was convicted 18 years ago of molesting a Boy Scout.

Donald Fricke, 41, of Milford, was convicted in 1966 of fondling a 14-year-old boy when he was a Scoutmaster at Old Settler's Boy Scout Camp in Milford, according to Superior Court records. But the Boy Scout organization was unaware of his criminal record until two weeks ago, said Kenneth

Quinnipiac Council in Hamden. Prowse said the organization keeps track of all members with convictions, but he was unaware of this incident because a 1982 flood wiped out the Scouting records. He later conceded, however, that Fricke had rejoined the organization in 1977, five years before the records were washed away. Current council files show no record of the 1966 incident, he said.

Prowse also said the council was unaware of the molestation because of a high turnover in leaders and no full-time staff at the camp, which has since been developed into residential housing

here as far as I can tell," he said.

He said someone wrote the national office in the 1960s about the Fricke case, but the organization never moved to oust Fricke because there was no court verification. When Fricke tried to renew his membership in 1977, representatives of the national headquarters asked area leaders whether there was any reason to deny membership. Prowse said the local officials told national organization they had no reason.

Although Prowse was unaware of the incident, a parent of a Boy Scout, who requested anonymity, said his son

about a month ago at a Scout meeting. He told another parent who reportedly said he had just learned about the conviction and notified Scout executives.

In a telephone interview, Fricke denied any knowledge of the convictions, calling them "rumors." But when confronted with details, Fricke said "This was a long time ago. There has been nothing since."

Fricke said he will meet with his attorney.

"I believe everyone is entitled to a second chance," he said. "Why after 20 years, why there a concern?"

Police and court records indicate the molestation occurred May 7, 1966. The victim awoke when Fricke unzipped his sleeping bag and began fondling him, the records said. They said the boy told Fricke to leave, but he did not report the incident until weeks later. His parents, noticing a disturbing behavioral change, finally convinced him to talk about the problem, the reports said.

Fricke was sentenced to concurrent one-year jail terms for indecent assault and risk of injury to a minor. But the sentences were suspended and he was placed on probation, with the requirement he receive psychiatric help for three years.

Risk of injury to a minor is defined in state statutes as wilfully or unlawfully causing or permitting any child under age 16 to be placed in a situation where his life, limb, health or morals are endangered or impaired.

Indecent assault, a charge that is no longer on the books, was vaguely defined as an overt act which does not need a description unless the accused requests the court to

the city nine years. He was a Boy Scout unit commissioner on the district level, in charge of ensuring that leaders take advantage of program and training opportunities. Fricke worked with the boys in the Order of the Arrow, a Scouting honor program, and recently received its highest tribute, a vigil honor.

Jane Platt, whose son belongs to the Order of the Arrow, said she was surprised to learn of the conviction.

"We talked to our son about this because we realize it happens in Boy Scouts from time to time," she said. "It's difficult to know what to do. My only concern is whether he is likely to cause any problems."

Another parent, Shirley Ellis, said Fricke deserves a second chance.

"I think he has made a great deal of good influence on my son," she said. "He has helped out my son a lot."

Roland Walter, a Milford Scoutmaster, said Fricke's conviction was upsetting, but not surprising.

"It was a problem in the

ly banish him from Boy Scouts. Anyone convicted of charges involving sexual assault or molestation is not allowed back into Scouting, but Prowse said he wanted to give the case further study.

"Can you hold something against someone for that long time ago?" he asked. "It depends what's happened since. If he has received psychiatric treatment, then we have to take a hard look at that."

But Prowse said he did not look into the possible success of Fricke's psychiatric care. Instead, the council asked for Fricke's resignation, saying he failed to meet the criteria of a role model for the Boy Scouts.

Rafel Chavez, a spokesman for the National Boy Scouts of America in Irving, Texas, said the national organization would not intervene.

"If this occurred 18 years ago, and he was a model leader since then, it's hard to say. We're not God. We're not a jury," he said. "If there is a danger here, then they (members of the local council) have the right to remove him."





Alfred D. Morin has just informed us that Donald Fricke, whom your council placed on the Confidential File in October 1966, is currently registered with Troop 708.

As you can see from the enclosed photo copy of the charter application, Mr. Fricke's status was given as "Re". Since we do not check "Re" Scouters against the Confidential File, we issued a certificate to Mr. Fricke. This points up the extreme importance of your registrar checking the status of every adult Scouter registered by your council. "Re" means same position, in the same unit as last year. Obviously, in Mr. Fricke's case, his status was not checked because he was last registered in Troop 707 and when he was placed on the Confidential File his name should have been removed from your records.

We suggest you take immediate steps to remove Mr. Fricke from Troop 708 and recover his current registration certificate as quickly as possible. We have already deleted his name from National records. We also suggest you correct your registration procedures so that this sort of unfortunate occurrence does not happen again.
