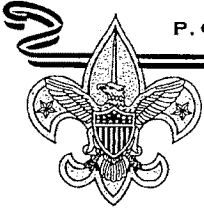

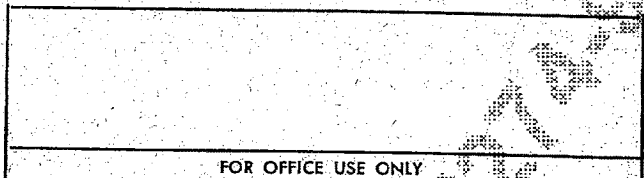

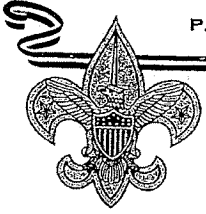

I regret very much the fact that I must request that you:

- a. separate Jack Gort as Scoutmaster of Troop 19 and register Harvey Johnson as Scoutmaster of Troop 19 (see enclosed separation notice and additional enrollment blank).
- b. drop Jack Gort and place his name on our confidential list of men who should not be registered in Scouting, anywhere, anytime in the future.

On a number of occasions, Mr. Gort took indecent liberties with Scouts in his troop and he is, at the present time, receiving the counsel of his minister, medical treatments by his doctor, and psychiatric treatment by a well-qualified psychiatrist.
