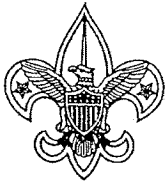

~~I am committee chairman of Troop 6, Cincinnati, Ohio. On July 4, 1984, while visiting my son at BSA Camp Hook, Carlisle, Ohio (operated by Moundbuilders Council), I was given some disturbing information concerning Richard J. Gruber, our present Scoutmaster.~~

~~Tom Scott, camp director, (I understand that he is a paid scout official) and Roger Brummett, program director, told me that approximately 24 years ago Mr. Gruber was caught engaging in a homosexual activity with a scout executive. Mr. Scott told me that he had been authorized by his superior (not identified) to relay this information to me in my capacity as committee chairman. I asked Messrs. Scott and Brummett for verification of this incident. They told me that they personally had none except to the extent that they received the information from Joseph Quick of the Dan Beard Council. Additionally, they both informed me that National headquarters was fully aware of this situation with Mr. Gruber and that his name was on a list of "undesirables".~~

~~Mr. Scott was quite emphatic in his concern for the safety of our boys based on Mr. Gruber's background. Accordingly, in order that the committee may make a reasoned, informed judgment regarding Mr. Gruber, I am formally requesting that National headquarters provide me with any and all information that you may have concerning Mr. Gruber. Furthermore, I am asking that you direct your local scout executive to provide any and all information he may have concerning Mr. Gruber.~~

~~Finally, I bring to your attention that Mr. Gruber is registered with the scout organization. Thus, if the information given to me by Messrs. Scott and Brummett is correct, I would like an explanation as to why it has not been provided to the troop committee before now.~~



On August 2, 1984 Mr. Joseph Quick, Scout Executive of the Dan Beard Council in Cincinnati, called me. He had received a copy of a letter from J. L. Tarr to Mr. Daniel J. Roketenetz, who is the chairman of Troop 6 of the Dan Beard Council.

He asked for a copy of the original letter, which was sent to this office by Mr. Roketenetz. This I will supply to Mr. Quick.

Mr. Quick asked who told Mr. Roketenetz that Mr. Gruber had originally been caught engaging in activities that were unacceptable. After some discussion and looking at our files, Mr. Quick discovered that Roger Brummett was the Scouting Coordinator at the time there were other problems in Troop 6 related to leadership. In 1983, Mr. Gruber tried to register and I discussed the matter with Mr. Quick. I indicated that we had a very weak case in our files related to him. Mr. Quick contacted the minister of the Church which sponsors the troop and also had communication with the chairman and the Scouting Coordinator at that time. The church decided, based on the time which had lapsed and our very weak file, that Mr. Gruber should be registered on a precautionary basis. This was done.

When Mr. Roketenetz wrote to us in July 1984, he indicated that Tom Scott, the camp director and Roger Brummett, the program director of the Moundbuilders Council Camp Hook, told him that Mr. Gruber had been caught engaging in homosexual activities many years ago. He asked for more information concerning this. Mr. Tarr's letter referred him back to the council, since the council had kept the chapter organization informed as any change in events took place.

This information should be in our file for future reference.

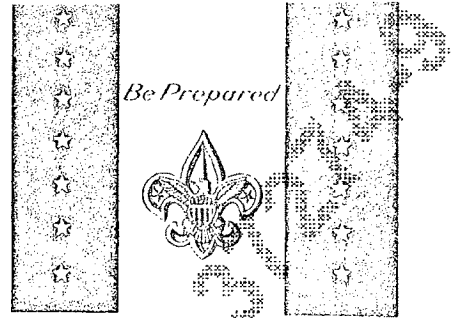

I'm enclosing a statement by our former lodge chief. The investigation by the security officer at one of our large firms has resulted in two resignations.


Both men admitted, in presence of two witnesses, that they had engaged in sexual activities with boys. Their resignations are enclosed. They are:
