# Sexual assaults alleged

## Ex-Big Brother indicted in cases involving boys

TRENTON — A Mercer County grand jury yesterday indicted an East Windsor karate instructor and former Big Brother on charges he molested two young boys and had sex with two others.

Paul Longeway, 45, of the 200 block of Bolton Road was charged in a 23-count indictment with multiple charges of aggravated sexual assault, sexual assault, criminal sexual contact and endangering the welfare of a child, said Assistant Prosecutor Cynthia Liccardo.

Longeway, who is being held at the Mercer County Detention Center under \$100,000 bail, could be sentenced to up to 40 years in prison if convicted of the charges.

Liccardo divulged little information about the victims, other than to say they ranged in age from 7 to 18 and that the assaults occurred between June 1985 and July last year.

She declined to say whether the victims were members of his karate class or whether they met him through the Big Brothers program.

Longeway was arrested in July after a 7-year-old boy told his mother Longeway allegedly molested him after a canoe trip. An investigation by local police revealed that Longeway also had a sexual relationship with the other three boys, Liccardo said.

At the time, Longeway protested his innocence.

"I've lived here 11 years and there have not been any such incidents of this nature that have come to light," he told Superior Court Judge Thomas DeMartin at his arraignment. "If I was a child molester, it would have come to light sooner."

Liccardo said there were other incidents of molestation involving Longeway.

In 1971, while a Boy Scout troop leader in West Chester, Pa., Longeway allegedly had sexual relationships with several youths. Longeway was scheduled to meet with concerned parents but disappeared and was not seen in that community again, Liccardo said.

Two years later, while teaching chemistry in an unidentified Wisconsin town, Longeway again faced sexual assault charges and fled the area, the prosecutor said.

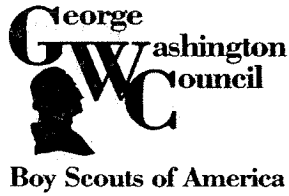

Longeway, a scientist with Princeton Scientific Enterprises Inc., was arrested Thursday on charges he sexually assaulted a 7-year-old boy.

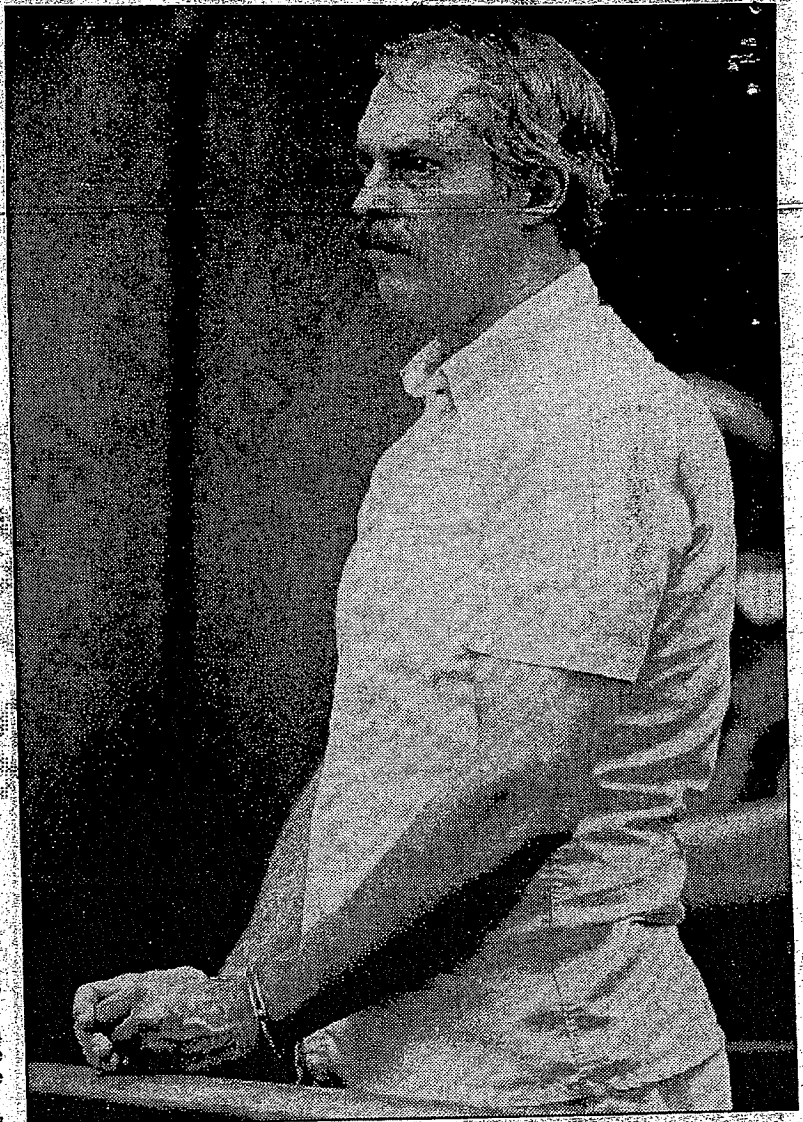

Pursuant to our phone conversation of May 29, 1991, the following is a summary of the concerns and allegations rendered to me on the phone by [REDACTED] 1415 Williamson St., Madison, WI 53703 - Telephone: (608) 256-1056. He is a graduate student at the University of Wisconsin - Madison.

[REDACTED] called our office on May 28, 1991, asking if we knew the whereabouts of Paul Longway. The purpose of his request was that he ([REDACTED]) wanted to reach Paul Longway to "counsel" him. [REDACTED] says he is a drug rehab counselor.

[REDACTED] related that he was concerned that Paul Longway was hopefully not still sexually abusing children. [REDACTED] related the following:

Paul Longway abused [REDACTED] sexually about 21 years ago. [REDACTED] was a Webelos Scout, and Longway was very "close" to his family. His abuse was not too serious and [REDACTED] is handling it.

Longway also sexually abused [REDACTED]'s cousins and the son of a dentist. He took them on a private campout. Longway was a Boy Scout leader. The cousins lived in Fitchburg, Wisconsin.

[REDACTED] said that one cousin and the dentist's son are "pretty messed-up".

[REDACTED] believed that Longway moved to Pennsylvania and that some of his family visited Longway "awhile back".

I advised him that the BSA has a specific procedure, if Longway is registered in Scouting and that I would start that procedure.



SUBJECT: Paul Longeway

Dear Bill:

This confirms our conversation on the phone related to Paul Longeway. This individual has been on our Confidential File for several years and should not be registered.

Mr. Longeway has traveled under various names, by changing the spelling of his name slightly and also using different first names and sometimes using "Paul" as his middle name. In another situation he used "Paul" as his first name with a middle initial "A". He was registered in three or four different councils over a period of years and in each council was asked to cease being registered and active with the Boy Scouts of America. Since the names were different, we did not realize it was the same individual until some pieces began to fall together and we discovered that we were working really with the same individual who was traveling around the country involving himself in Scouting activities.

Thank you for the prompt response to our request for information concerning Paul Charles Longway. He resigned August 5 in preference to termination. He received severance pay and has departed.

He was reported to us by three Scouts of Troop 120, Boonsboro, Md., who were manually molested by him while on a Pack 20 Webelos Den overnight campout, this past winter.

The confusion you suggested can now be clearly identified as a carefully planned scheme to get back into Scouting after his hasty departure from Wisconsin.

To protect others who may be subjected to similar actions I provide the following: In November, 1973, Donald Barron, one of our District Executives, received a long distance telephone call from someone identifying himself as a District Executive in Madison, Wisconsin. He announced that Paul Longway was moving to our area and we should be sure to recruit him to work in Scouting. The information presented included the following: he is a widower whose wife was killed in an auto accident, an Eagle Scout, Vigil OA member, Woodbadger, District Training Committee Vice Chairman, Troop Leader and an ordained minister of the United Methodist Church who prefers to attend Roman Catholic services.

He arrived and became: a Webelos Den Leader in Pack 20, Boonsboro, Md.; Scoutmaster Troop 58, Downsville, Md. and member of the Washington County District Committee. He immediately demonstrated spectacular success in each job.

When a vacancy occurred on our staff he seemed like a Godsend. His application listed the Wisconsin District Executive as a reference. He said he would be talking with him and would ask for his letter of recommendation. It arrived, not at our Service Center, but through his home address.



In response to a call from Don Barron, of your staff, I researched our entire personnel jacket on the above named subject, and also reviewed our confidential file situation on a couple of suspected aliases.

There is a Paul Longway in our files, he was placed there in July of 1970 from Harrisburg, Pa. This "Mr. Longway" was at that time serving as Scoutmaster from 1966 through 1970 (the date of entry of a troop #90 in Mechanicsberg, Pa.). He was indicated to be a teacher at that time, approximately 5' 11", and about 190 pounds, and it was indicated that he had attended Messiah College, and Shippensburg College.

There is also Brian Paul Longway, who was entered in the files in November 1973 from the Menasha, Wisconsin Council. At that time he was serving as Scoutmaster of troop #1088, at the community of Marinette, Wisconsin. At the time of the instances of this situation, there was an effort made to get the parents of the boy, the Scout executive, and the Scoutmaster together. As soon as the meeting was called, the subject immediately quit his job, left town hurriedly for Pennsylvania. He also was a teacher.

In addition to above information, and apparently, because there was a rush to approve this applicant, his application does not include college transcripts from any of the colleges, and in addition there are many discrepancies, i.e., two different birthdates, at least two different social security numbers, confusion as to whether his Bachelors Degree was in Behavioral Science or Psychology, and whether his postgraduate work at the University of Wisconsin was in Chemistry or Psychology. Moreover, his application indicated him to be graduated from Shippensburg College, Pa., and the University of Wisconsin, Madison. Whereas, his N.E.I. information material shows him to have been from Messiah College.




Dear Paul:

We have had a recent incident with a Scout Master who took some provisional boys to a Scout camp last summer. In September, he was accused by two boys of moral indecencies and we have done an investigation of the incident with the boys and their parents and the accused Mr. Brian "Paul" Longway of 1135 Florence Street, Marinette, Wisconsin.

Mr. Longway was a school teacher in Waukesha, Wisconsin. In September of 1973, when I confronted him with these accusations, he denied it, at which time I insisted on a meeting with the boys involved and Mr. Longway, to discuss the matter further. He agreed to attend this meeting. Between that time and three days later when the confrontation meeting was scheduled, he packed his belongings and left for Pennsylvania. He did not inform the school system where he worked, nor myself, so we feel that the boys were telling the truth and I would therefore like to place his name in the confidential file and prevent him from serving in the Boy Scouts of America.

I have attached a letter from Mrs. [REDACTED], mother of one of the boys, explaining the incident. If you need any additional information please let me know.

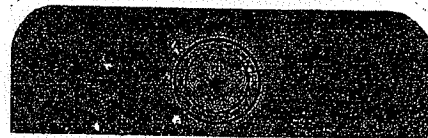

**CITIZENSHIP AND AGE REQUIREMENTS**

Every person serving in any official relationship with the Boy Scouts of America shall subscribe to the statement of religious principle, the Scout Oath and Law, and the Bylaws. Enclosed is a confidential record sheet on David Paul Longwy, Scoutmaster Troop 135, District #1, Chester County Council #539. Moral charges have been brought against Mr. Longwy in July. During the week of July 26th the troop committee were in the process of conducting an investigation to determine the validity of these charges. Several days after they started their investigation Mr. Longwy left town and to our knowledge has not been heard from and we do not know where he is, nor does his wife. Also, for your information, he left Parkesburg on his motorcycle taking several Scout uniforms, sleeping bag and miscellaneous Scout equipment.

Following the investigation the troop committee was able to secure a statement from one of the parents that his son was encouraged to commit an immoral act. A copy of this letter is attached.

I do not know if the attached letter is adequate to recommend that David Paul Longwy's name be placed in the Confidential File. We have not been able to get a statement or resignation from Mr. Longwy, but on August 5, 1971 we removed his name as SM, T-153. The investigation is still underway, but due to his mysterious disappearance and leaving with only Boy Scout uniforms and camping gear I felt that you should be notified.

In the early spring of 1971 at the Chester County Council's Spring Camporee at Hibernia Park, Paul Longwy, then Scoutmaster of Parkesburg Boy Scout Troop 135, made a sexual advance on my son, who was a member of the troop.

According to my son, the Scoutmaster and several scouts were sleeping in one of the leaders' tents under a common blanket of sleeping bags that had been zipped together. The scouts' pup tents were wet inside and out from a drenching rain during the night.

Paul Longwy took my son's hand sometime during that night and placed it upon his penis. Without acknowledging the incident and somewhat dumfounded, ("I didn't know what to do"), my son removed his hand from Paul's body.

Nothing was said of the incident immediately, my son said, for fear of getting Paul in trouble. He also admitted he was embarrassed by the incident. After several other boys had admitted to similar experiences, however, my son spoke freely of his own experience.

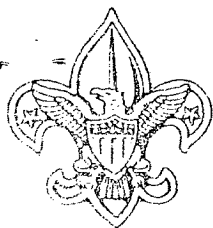
