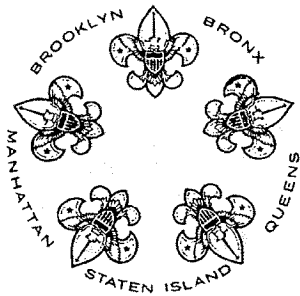

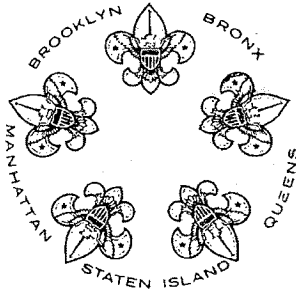

INCIDENT REPORT

At approximately 3:30 PM, Sunday, Aug 4, a Mrs. [redacted] asked the Kunatah Director, [redacted], to help her with a problem. It seems that her son, [redacted] - Troop 526 (Parkway Dist), presently at Camp Kunatah, had a bad experience.

Mrs. [redacted] stated that [redacted] had been approached by a Mr Robert Mates (Parkway Dist Trng Chm) who was working as a leader with the Troop (consolidated), on Aug 3. Mr. Mates had asked [redacted], after the evening campfire, if he would like to have a 'sexy party' and [redacted], thinking Bob meant sexy pictures, said yes. About 12 P.M., Bob came to [redacted] leanto & asked him if he'd like to 'play with his penis'. Not to appear afraid, [redacted] said all right & 'enjoyed' the experience, but refused Bobs requests for further activity, pleading tiredness and finally, that this was not a moral act. Bob then returned to his own leanto after asking [redacted] to tell no-one.

Mrs. [redacted] further stated that she had promised her son not to tell anyone what had happened, but she thought it was in fact necessary to take some positive steps to prevent further problems. She would leave her son at Kunatah as originally planned.

[redacted] discussed the incident with Elmer Greey, TMR Director within two hours of the conversation with Mrs. [redacted]. Elmer requested an after action (incident report & would call the Boro and District involved.

Aug 5 (Mon) at approx 1020 AM [redacted] was confronted with incident in an effort to get the complete story ([redacted] and [redacted] were interviewers). The boys story jibbed with that of his mother. [redacted] did not appear disturbed and he was anxious that no action be taken against Bob.

The Scoutmaster of Troop 419, Saul Gershomowitz (the parent unit) stated that Bob Mates was with him constantly during the entire evening (Aug 3) and Bob was asleep before he (Saul) went to bed (they are in the same leanto).

At 2 PM Aug 5 all above events were reviewed with Elmer Greey and he informed Harvey Smith, Boro Exec, BKlyn.

The above info is to the best of our knowledge a true statement.
