Although you state that Mr. McDonald was reportedly accused of sexual perversion, we really need more detailed information. Just what actually happened? What situation or incidents occurred to cause these charges to be made? We would very much appreciate your writing us a letter giving us the complete story.

We would also be most appreciative if you could obtain for our files a statement from the boy or boys involved or from their parents. This information is most important for future reference purposes and it would certainly strengthen our position of refusing to accept any future application for registration we might receive from this individual.

Enclosed is a confidential record sheet which we would appreciate your filling out and returning to us as soon as possible together with the above requested material. However, unless we receive this documentation, we will not be able to place this man's name on the Confidential File.
