

DEAR HOWARD:

THIS IS TO REPORT THE NAME OF ION O'BRYON FOR THE CONFIDENTIAL FILE. HE IS THE FORMER SCOUTMASTER OF OUR TROOP 252, SPONSORED BY SACRED HEART CHURCH OF SAN JOSE. HE WAS LAST REGISTERED TO FEBRUARY, 1968, AT WHICH TIME HE WAS DROPPED BY THE TROOP. HE HAD ALLEGEDLY MISHANDLED A CANDY SALE ACCOUNT INCURRED WITH MACFARLANE'S CANDIES AND DID NOT MAKE PAYMENT TO THE COMPANY.

HE HAS CONTINUED A CURRENTLY UNREGISTERED RELATIONSHIP WITH ONE OR TWO NEWLY ORGANIZED TROOPS AND HAS CHARGED SOME RATHER HEAVY SCOUTING EQUIPMENT BILLS AT MACY'S IN SAN JOSE TO HIS FORMER TROOP 252 IN THE AMOUNT OF SOME \$155.00.

EFFORTS ON OUR PART TO HAVE HIM MAKE RESTITUTION HAVE FAILED. WE REFERRED BOTH MACFARLANE'S AND MACY'S TO THE LOCAL DISTRICT ATTORNEY'S OFFICE. APPARENTLY NO SETTLEMENT HAS BEEN MADE AS OF THIS TIME.

IN THE INTERIM THE COUNTY JUVENILE PROBATION DEPARTMENT HAS RECENTLY INFORMED US THAT HE HAD BEEN ARRESTED ON THREE COUNTS OF CHILD MOLESTING. HE HAS NOT BEEN IN A REGISTERED CAPACITY SINCE ~~February~~ ^{February} 1967 AND WE HAVE INFORMED HIM THAT WE WOULD NOT APPROVE HIS REGISTRATION AS A SCOUTER.

HE IS THIRTY-THREE YEARS OF AGE AND WAS REGISTERED WITH TROOP 252 IN SEPTEMBER, 1966. HE IS MARRIED AND, I BELIEVE, HAS TWO CHILDREN. HE IS EMPLOYED IN A WHITE FRONT STORE WAREHOUSE IN SAN FRANCISCO. HIS LAST KNOWN ADDRESS WAS 669 MENKER AVE., APT. 3, SAN JOSE, CALIFORNIA.


