
Dear Alden:

At the request of Mr. Paul Terril of the Illinois Youth Commission, the above named suspect was examined by the polygraph detection of deception technique at the Illinois Crime Laboratory in Joliet, Illinois, on December 14, 1965.

The examination was to determine whether or not the suspect had participated in any sexual acts with the victim.

RESULTS:

There were significant emotional disturbances indicative of deception on the subjects polygraph records on the following questions:
