Whom It May Concern

1. The following statements are made in order to bring to the attention of all concerned the suspicions, concerning the character of Thomas Putnam, currently registered as an Assistant Scoutmaster with Troop 122, Frankenwald District, Transatlantic Council, Boy Scouts of America.
2. I have been associated with Thomas Putnam for approximately one year. I became acquainted with him when I accepted a position as a member of the Troop Committee for Troop 122 in November 1968. In May 1969 I became Scoutmaster of the troop and became even more closely associated with him. During the major portion of this time I considered him as a good scout leader and a close friend, even though his conduct during scouting activities did not always reflect the highest ideals as a leader and an example to the young boys.
3. His lack of character was first evidenced by telling a lie when he originally registered with the troop, stating he was 21 years of age. After becoming involved in a vehicle accident in December 1968 and the subsequent investigation, it was discovered that he was only 20 years of age when he registered with the Troop. When confronted with the falsification he stated that he had given his age as 21 because he wanted to become a Scoutmaster.
4. According to Putnam, his mother is Apache indian, which I have no reason to doubt. He is well versed in indian lore, dancing, etc, and as such was very popular with the boys who desired to learn more about indians, their habits, customs, dances, etc. He formed an indian dancing team in the troop which was very popular and performed many exhibitions at public activities such as carnivals, Courts of Honor, Cub Scout Pack meetings, Army organizational day activities, etc. In his role as an indian, he became the idol of many of the boys in the troop. Some of his indian stories and experiences which he related to the boys left a doubt in my mind as to their credibility. However, not being as well versed as he in

Indian lore, I was at a disadvantage in questioning the validity of his statements.

5. Thomas Putnam's patience and understanding in working with boys leaves much to be desired. On many occasions I have seen him lose his temper and act more like a boy than an adult leader, demanding almost impossible tasks from the boys, threatening them with elimination from the troop activities and in some instances, even threatening physical punishment for not having done as he demanded. I made it quite clear to Putnam on several occasions that I could not and would not tolerate abusive actions or language toward the members of the troop and he assured me he would make efforts to control himself.

6. At the present time, as I reflect on some of Putnam's activities during our camp outs, I can more readily see that he was not acting in the capacity of a good assistant scoutmaster. He was very, very friendly toward a select group of the younger boys, devoting the major portion of his time to them, rather than sharing his time equally among all the members of the troop. This select group, I finally discovered, had been given special privileges in many instances which created both jealousy and animosity among the troop members. In counseling Putnam on his lack of mature leadership he became quite emotional, explaining to me that he was only a boy himself and should be expected to act as such. In view of his promises to try to act more mature, both I and the Troop Committee, with whom I discussed the situations, agreed to give him the opportunity to try and improve himself in scouting. On every camp out that I can recall with the troop he has managed to find some plausible excuse to have one of the boys sleep with him, together, in the same sleeping bag. The excuses included: The boy is homesick and scared, the boy is sick and he was concerned about him becoming seriously ill, the boy gets too cold by himself and, he had promised the boys parents he would act as "baby sitter" over the week end and felt a responsibility toward the boy and his parents which he could only fulfill by keeping the boy close to him at all times.

7. During the latter part of September of this year Putnam proposed an "Indian Camp Out" to the troop and they readily accepted the proposal. It being a boy's program and in keeping with the policy of letting them decide on their program I went along with the idea even though I had doubts as to whether the program for the week end was wise considering the cold weather. Based on Putnam's suggestions, the boys would hike to the camp site on Friday afternoon in Scout uniforms, change in to indian clothing (loin cloths) upon arrival and stay dressed as such until the hike back on Sunday afternoon. The sleeping gear consisted of two blankets. The boys were to build indian type shelters in which to sleep which were to be constructed

with brush in the form of a "lean to". The construction of the shelters presented a problem due to the lack of loose brush in the area which was known prior to the camp out. The weather turned quite cold during the week end and I told the boys to put on sufficient clothing to keep them warm. Putnam was very much against my directions, preferring to see the boys run around in a state of semi-nudeness it seems. I had received many calls from parents prior to the camp out concerning their son's welfare and I had assured them that I would take any action necessary to prevent their sons being unduly exposed to the elements and becoming sick.

8. During the month of October I was talking with a group of boys, including one, Duane Chalmers, who had formerly been a member of the troop until he quit to participate in sports. During the course of the conversation he told me that Putnam had been taking unnatural liberties with several of the boys, including himself, in one instance. Questioning other boys in the neighborhood and in the troop I heard the same stories from several boys. This disturbed me considerably and I discussed the situation with the Chairman of the Troop Committee. It was mutually agreed that, in view of the stories, which established a very definite suspicion, Putnam would have to be removed from Troop 122 and action taken to eliminate him from further association with Boy Scouts. It was decided to confront him with the accusations on October 17, prior to a scheduled Scout Leader's Conference.

9. The troop had planned a week end camp out for the 25th and 26th of October and we decided to let Putnam stay with the troop on the camp out in order to allow Mr. Bernhard Frenkel, who has since taken my place as Scoutmaster, and I to more closely watch his activities and determine if the boys tales were valid. On the night of October 25th Mr. Frenkel, Putnam and I went to sleep in a tent set up for the leaders. However, during the night, while Mr. Frenkel and I were asleep, Putnam got up and went to one of the boy's tents and got in the sleeping bag with [REDACTED]. The following morning there seemed to be a general feeling of animosity toward Putnam from the troop boy leaders especially. They had given him a nickname of "Mrs. Magoo" and refused to cooperate with him in any activity. In pursuing the matter I discovered that some of the boys had mentioned his homosexual activities with them to other boys and such a hatred for him had been generated that they wanted to gang up on him and give him a beating. I managed to prevent any violence during the outing, but Putnam became so aware of the situation that he gave me his resignation from the troop on Sunday, October 26 which I accepted and invited him to attend the meeting on the following evening which he promised to attend. He did not attend the meeting and the scout leaders present were informed of our suspicions by Maj T.A. Todd, Chairman of the Troop Committee for Troop 122 and Asst. District Commissioner,



10. I contacted two parents, whose son's had been molested (according to the boys) and asked them to question their son's and, if the stories were true, to provide either myself or the Troop Committee with statements which could be submitted to the Scout Executive and Putnam's Commanding Officer to initiate whatever action might be deemed appropriate. The parents involved are [REDACTED], 4th Armored Division Support Command, who has two sons, [REDACTED] and [REDACTED] in the troop and [REDACTED], 130th General Hospital who has two sons, [REDACTED] and [REDACTED] in the troop. I have talked to both parents since they talked to the boys and they inform me that they are convinced that Putnam has had homosexual relations with their sons. However, to date, they are reluctant to make statements. Whether this is to avoid embarrassment to them and their son's or merely "not wanting to get involved", I cannot determine.

11. I am convinced, in my own mind, that Thomas Putnam does have homosexual tendencies and should be prevented from further participation in the Scouting program and action should be taken by his commanding officer to refer him to medical personnel for evaluation and help.

12. I wish to emphasize that my statements are in no way intended to be construed as an accusation since I have not personally observed any overt acts. My statements merely relate to my observations of his activities and heresay from scouts and their parents.

I observed that his shirt was unbuttoned and as he spoke to Lt. Col. Dickson, he buttoned his shirt.
