
Dear Mr. Hatfield:

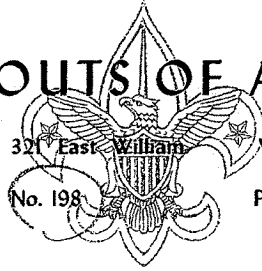
