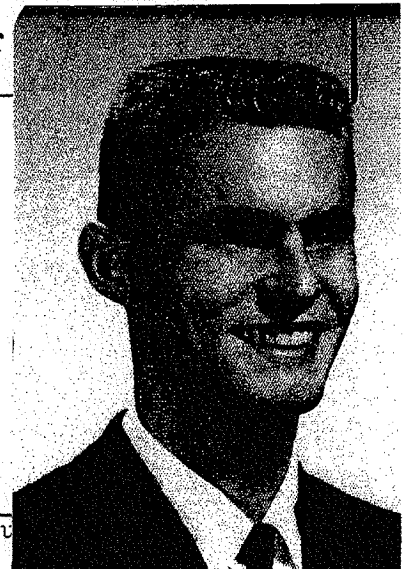

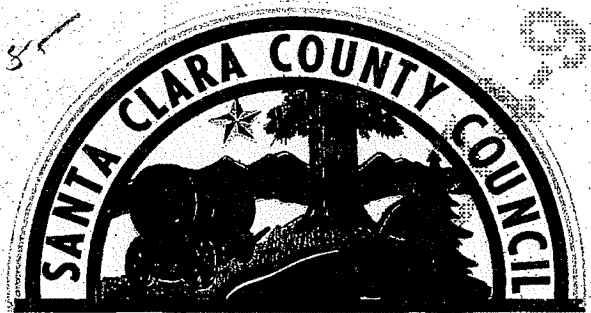

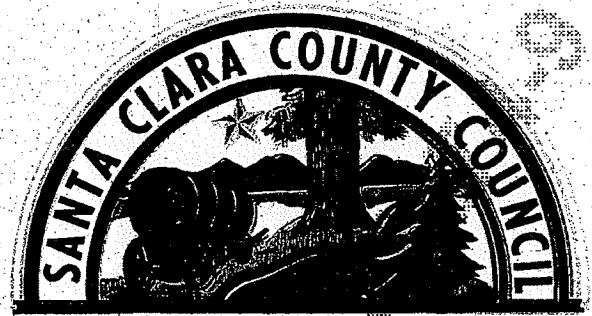

May I just take a moment to alert you to a possible situation. A Richard Montgomery Hiltner, a former professional Scouter in Ridgewood, New Jersey (October 1964 to December 1965) is now in your council area. He is in the military, apparently in the Air Force, and his address is:

Mr. Hiltner was born on June 22, 1942 in Washington, D. C.; living at least part of his young days in Silver Spring, Maryland; is a graduate of Salem College, Salem, West Virginia; was on the Philmont staff in the summer of 1963; is single; 5'10"; weighs 154 lbs; professes the Methodist religion; is a graduate of the 260th Training School.

We are advised that Mr. Hiltner has established contact in one of the units in your council, or with one or another of council personnel to become actively associated in Scouting in your council area. Because of this, we are writing to advise you that we would be unwilling to accept Mr. Hiltner's registration in any position in the Boy Scouts of America and recommend that you, under no circumstances, allow him to become associated in any capacity with any Scouting activity in your council. Of course, under no circumstances should you tell Mr. Hiltner anything other than the fact that you are advised the Boy Scouts of America is unwilling to accept his registration.

I hope it does not become necessary for you to take any action in connection with Hiltner, but if it does, I am sure that you will adroitly handle the situation.

Yesterday, [redacted] called you from my office to report that a former District Scout Executive from this council is reported to have had homosexual relations with one of our Scouts. I have spoken with the boy and his father, and the boy admits that this relationship existed for an extended period of time during 1965.

Dick left here for military service in December, 1965 and has been active in Scouting on two military bases during the past year. He has just been transferred to California where he has also established contact with either a council or a unit.

During the past year, Dick corresponded with several boys from our council. Last month he returned here for a visit before leaving for California. He contacted quite a few local boys including the one involved. Since Christmas this boy has received three letters from Dick, two of which contained references to their former relationship. These letters were read by the boys parents and this is how the matter became known to us. I have these letters and have been asked by Yorel Harris to hold them although the boy and his father hope that they can be destroyed.

As far as we know, only the principle parties have knowledge of this matter although we cannot help but suspect that other boys have also been victims. The parents are willing that we dispose of the matter in any way we see fit but they, and I, are most anxious that any further correspondence between Dick and all local boys cease. I have therefore written directly to Dick to tell him to stop corresponding with boys in our council.

If you need any further information from me I will be willing to do what I can.

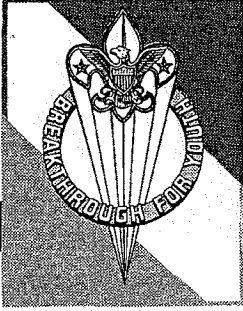
