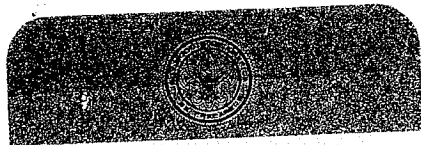

Mr. Kimble called on August 8 and, since I was not present, asked me to return his call on Monday, August 11. This was done.

Mr. Kimble stated that he did not know the reason that his registration had been refused. I indicated that this happened back in 1966 at which time he surrendered his registration certificate and Order of the Arrow membership card. He still indicated that he was not familiar with this situation.

He intends to press for an answer and I, therefore, suggested that he ask the Scout Executive to have the President of the council appoint a review board. I did indicate to Mr. Kimble that our records are held confidential and that no publicity is given which would cause anyone to know of this situation. A review of the situation could bring out other facts related to the case.

I gave him Mr. Fultz' name and suggested he contact the Valley Forge Council.

Kimble is 5' 10" tall, weighs 180 lbs. He has black straight hair, wears glasses and is neat in his appearance. He attended Salem College in 1961-62. It is our understanding he was released from the Humanics Program for the same reason. He graduated from the Upper Darby High School in 1958. He is currently employed by the Royal Typewriter Co., Inc. at 3913 Chestnut Street, Philadelphia. He is single and has not been married.
