When I last talked with Mr. White, he was attending the Latter Day Saints Church of Cocoa. It seems that the Latter Day Saints Church plays the dominant role in his life.

MARITAL STATUS: Married, but separated. I do not know if he has any children. I do not know his wife's name. His wife is in the Armed Forces. I do not know her duty station. Mr. and Mrs. White do correspond by mail. I believe, from my talks with Mr. White, that he desires to rejoin his wife. I do not know if he has been married before.

EMPLOYMENT: I do not know the firm Mr. White is associated with. He is a bookkeeper.

COMMENTS: Mr. White, by his own admission, is bi-sexual. Mr. White was picked up by a local law enforcement agency on or about January 19, 1966 for making a contact. I assumed this contact, made by Mr. White, was directed towards the arresting officer. Mr. White contacted me on January 21, 1966 to resign from Scouting because of this arrest. Mr. White assured me that he had not approached any Scouts or Scouters sexually.
