It is a shame that our correspondence seems to be limited to the more undesirable aspects of our work; but some of those days we may be able to write each other a pleasant letter.



It seems that you and I have regular correspondence about some of the more undesirable elements of our work.

We have another Scouter who should be put on the confidential list. We do not have too much specific information on this man, but we have enough to convince us, beyond any doubt, that he is certainly not fit to be in Scouting. He's name is Herbert T. Abney. He is currently registered as an Assistant Scoutmaster with Troop 39, here in our Council.

Three separate occasions have come up where he has been involved with boys in an immoral way and in one instance, we were able to talk with one of the boys' fathers and have pretty definite verification of the facts. We have taken his registration card from him and he is no longer associated with Scouting, here. He does have a uniform with insignia on it indicating he had previously been registered in Houston, Texas.

The only specific charge which has been made against him by the police department was one on indecent exposure, for which he was found guilty.

I have included here most of the information we have and if it is necessary to fill out another form, we will be happy to do so.
