1. When a boy or adult transfers from one unit to another. (Viz., pack to pack, pack to troop, troop to troop, troop to Explorer unit, Explorer unit to Explorer unit.)
2. When an adult changes position within a unit or council.
3. When a Boy Scout or Explorer reaches 18 years of age and registers as an assistant Scoutmaster or an associate Advisor.
4. When a member dies.

When a boy or an adult pays a registration fee, he is entitled to membership until the expiration date indicated on the membership certificate.
