SUBJECT: (Personal and Confidential)

The following person under investigation as a Scouter has attached himself to Troop 135, District 2, Queens as a Scoutmaster. He is not registered at this time with the Troop. His name is Cal Diva, 24 years old. He has another alias of Carl Lavista, another alias of Calvin DeVyer and another alias of Cal Divera. His listed address is 34-08 81 Street, Jackson Heights, N.Y. He has claimed that he has been registered in the Bronx and in Chicago and I have been informed by the District Executive of District 9 that he was registered at one time as an Assistant Scoutmaster, Troop 80, Kew Gardens using the name Cal Divera. At that time he was arrested for impersonating a naval ensign and because of moral charges brought against him by parents. A priest took this troop out of his church. This was sometime in 1959.

He claims he is an Eagle Scout. As far as we know he is not registered at this time.

Approximate description is 6 ft. 3", rather slim, very charming and speaks well. He wears his hair long and it is light in color.

About two weeks ago he was arrested in Queens on moral charges with minor boys brought about by the parents in Troop 135. I understand also that he was arrested by complaints from the Catholic Brigade for moral charges.

According to additional information we can find he was arrested in Battle Creek, Michigan in 1956 for carrying concealed weapons. He was put on probation.

It is recommended by the District Executive of District 2 that he be placed on the Confidential List.

This is all the information I have at this time. If additional information is uncovered I will relay it to you.
