# Morals Charge Is Filed Against Local Scoutmaster

A 31-year-old Evansville scoutmaster has been charged in Circuit Court with sodomy. The case involves a 12-year-old boy, a member of one of the local three Boy Scout troops the man has led.

The charge was filed yesterday, against Alonzo E. Estes, of 1120 W. Indiana.

The charge came after nearly a week of investigation by police juvenile authorities, during which five statements were taken from

troop held its meetings, on camping and boating trips and in Estes' home.

The statements included names of 10 other boys allegedly involved in the incidents, police said.

Investigation of the case began last Friday, when the father of one of the boys called police. Estes was arrested and in City Court Friday night ordered held on a preliminary charge of assault and battery.

Bond in City Court originally set at \$10,000 was reduced to \$2000 Monday.

Circuit Judge Ollie Reeves to

day increased the bond from \$2000 to \$3000, after Prosecutor G. H. Roberts Jr. said he had evidence Estes was preparing to leave town. Roberts had asked for a \$10,000 bond.

Estes is free on bond.

Later Roberts asked for a change in judges and Attorney John Clouse was selected from a panel of three. Clouse immediately qualified for the case.

Estes also has led troops in Louisiana, Texas, Oklahoma and Hawaii, police said.

## Trial Date Stated In Sodomy Case

A 31-year-old Scoutmaster will be tried Jan. 24 before a Circuit Court jury on a charge of sodomy.

Special Judge John Clouse set the trial date Tuesday after overruling a motion to drop the charge against Alonzo Edward Estes of 1120 West Indiana Street.

Estes is accused of unnatural sexual activity May 7 with a 12-year-old boy. He pleaded not guilty Tuesday after Clouse denied the motion to drop the charge.

Estes is free on \$3,000 bond.

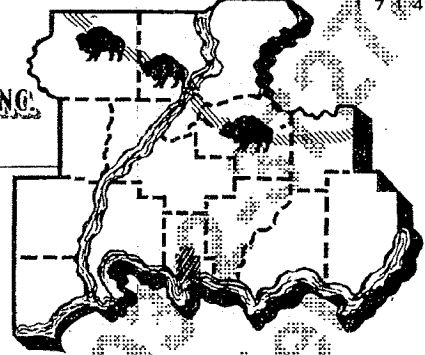

Alonzo E. Estes, currently registered as Scoutmaster of Troop 100 and Associate Advisor of Post 111 in District #5, is in jail on \$10,000 bond for assault and battery. However, the real charge is for molesting boys and so far they have secured some fifteen signed statements from boys. Very likely he will be sentenced but regardless of that there is no question concerning his guilt and we wish to have him placed immediately upon the "red flag" list, and his name removed from the unit roster. At the moment, there is some uncertainty as to the future of the troop but we will make every effort to save it and recruit a new Scoutmaster.

I believe there is a special form for us to fill out providing information and description of this man for your files. Will you please send this to us?

This is one of the worst situations of this kind that we have faced in this Council and you may receive letters from irate parents.
