Lee Gladden was picked up by Danvers police for homosexuality. Because of his place in the community they are not going to prosecute. Lee claims that this is the first time in this area, but admitted (to me) two previous experiences while in the armed forces.

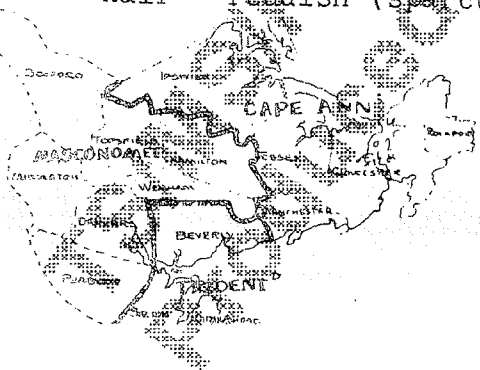
