Dear Paul:

Since May of 1974, we have been talking with George C. Lueck regarding the possibility of his being considered for registration in the Boy Scouts of America. Your correspondence on this matter was dated May 22, 1974.

On July 31, 1963 Lueck was convicted in Milwaukee County for indecent behavior with a child and has been in the Confidential File since that time.

Our Council Officers have reviewed all material that we were able to acquire, but have not met Mr. Lueck personally or held any type of hearing regarding this matter. Their attitude has been that if the Governor of Wisconsin would grant clemency and restore all privileges of citizenship to Lueck, then his re-registration in Scouting might be considered. Enclosed is a copy of a letter and a copy of the Executive Clemency which has now been granted.

We are now at a loss as to how to proceed.

I am taking this course of action. Enclosed is an application from Mr. Lueck to be the Assistant Scoutmaster of Troop 103 sponsored by St. Thomas Aquinas Catholic School and Holy Name Society, 1968 North 36 Street, Milwaukee, Wisconsin 53208. This application has been approved by Father Eugene S. Pocerlich.

Mr. Lueck apparently has the complete approval of this sponsoring institution and its Scout Committee who would be willing to support his request if given the opportunity.



Reference is made to your recent inquiry as to your arrest record. Our files indicate that you have the following arrest record with this Department:


- 11-23-69 Obstruct an Officer - \$37.00 total or 10 days Co Jail on 11-24-69

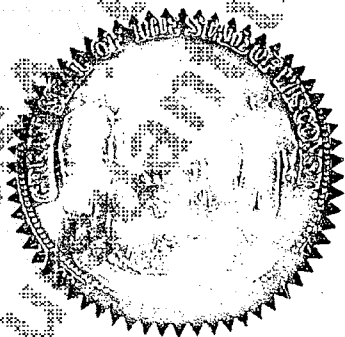

1. That on July 31, 1963, the client was convicted in the Circuit Court Criminal Division, Milwaukee County, Judge John Coffey presiding, of the offense of Indecent Behavior with a Minor, and was sentenced to the Wisconsin State Reformatory for a term of 3-1/2 years.
2. That the District Attorney in and for Milwaukee County was William McCauley, now deceased.
3. That the facts and reasons upon which this application is based are as follows:

I was paroled in January, 1965, and for the past nine years I have been in the situation where I have been deprived of bettering myself with working conditions. In the past, I have been hired and then terminated due to my past record.

I have lost my home and family for it has been nothing but disappointments due to this mishap. I have tried to better myself by living a clean and better life. I feel I have paid my debt to society in more than one way. If this one mistake I made was severed from the records, I could then better myself with the people and society I live within.

Just one example for instance. I was forced to leave the state of Wisconsin due to working conditions. I moved to California to try and better myself only to find due to the past record I was denied a job with Lockheed Air Craft. I worked there for one month and was then terminated. At the same time I was also denied the chance of becoming a member of the Moose Organization. I find it hard to believe this should be so, but it has been this way since my misfortune.

I am now in debt because of not being able to hold a good steady job. I have lost everything I have been working for in the past seven years. I have looked over my past, and if it were not for this one mistake, I would still have my family, home and a better position than I now have.

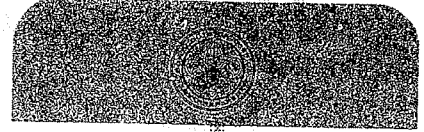
