As of August 5 he plead guilty in Superior Court to sex crimes involving a 9 year old boy and also an 8 year old boy. He is now being held for psychiatric examination. His confession is further supported by a hand written statement in which he described the lewd acts on two or more occasions.

His 14 year old brother is said to have participated in these lewd acts and the brother is now in the hands of the Juvenile Authorities. The Sheriff considers the brother a pervert also.
