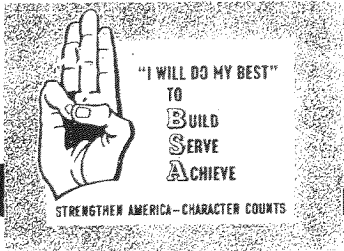

REPORT ON ORTTIS LLOYD SMITH AS RECEIVED FROM  
LT. BULLEN, DELAWARE STATE POLICE BY GUY V. SIMPSON, D.S.E.

On August 6, 1964, at approximately 5:00 P.M., one and one eighth mile off Howell School Road, Kirkwood, Delaware, Orttis Lloyd Smith, 1503 Lancaster Avenue, Wilmington, Delaware was arrested for oral Sodomy on a thirteen year old boy. The boy is a member of Troop 22, Shiloh Baptist Church. The boy involved was [REDACTED], age 13, whose home address is 1112 W. Fourth Street, Wilmington, Delaware.

This actually occurred at a place called Lums Pond. Smith reports that he took the boy out to the area to teach him about types of trees and wild life in the boy's work for a merit badge.

Smith talked to the boy about sex and girls and proceeded to unfasten Harold's trousers which dropped to the ground. He then unsnapped the boy's shorts which also dropped to the ground. At this point, Smith committed Sodomy "Peroris" on the person of [REDACTED]. The boy became frightened and ran away through the woods to a Service Station at Kirkwood, Delaware where the Station attendant called the Police.

First on the scene was Lt. Ogden of New Castle Police Department.

Smith followed [REDACTED] to the Station saying he was afraid the boy would become lost and he wanted to take him home. Smith was detained by Lt. Ogden who called Troop 2 of Delaware State Police.

Detective Frank Rassman arrived and questioned Smith. Smith admitted guilt and signed the confession. Magistrate Stefhurs of St. Georges, Del. set bail at \$500.00. Trial will be in Superior Court.

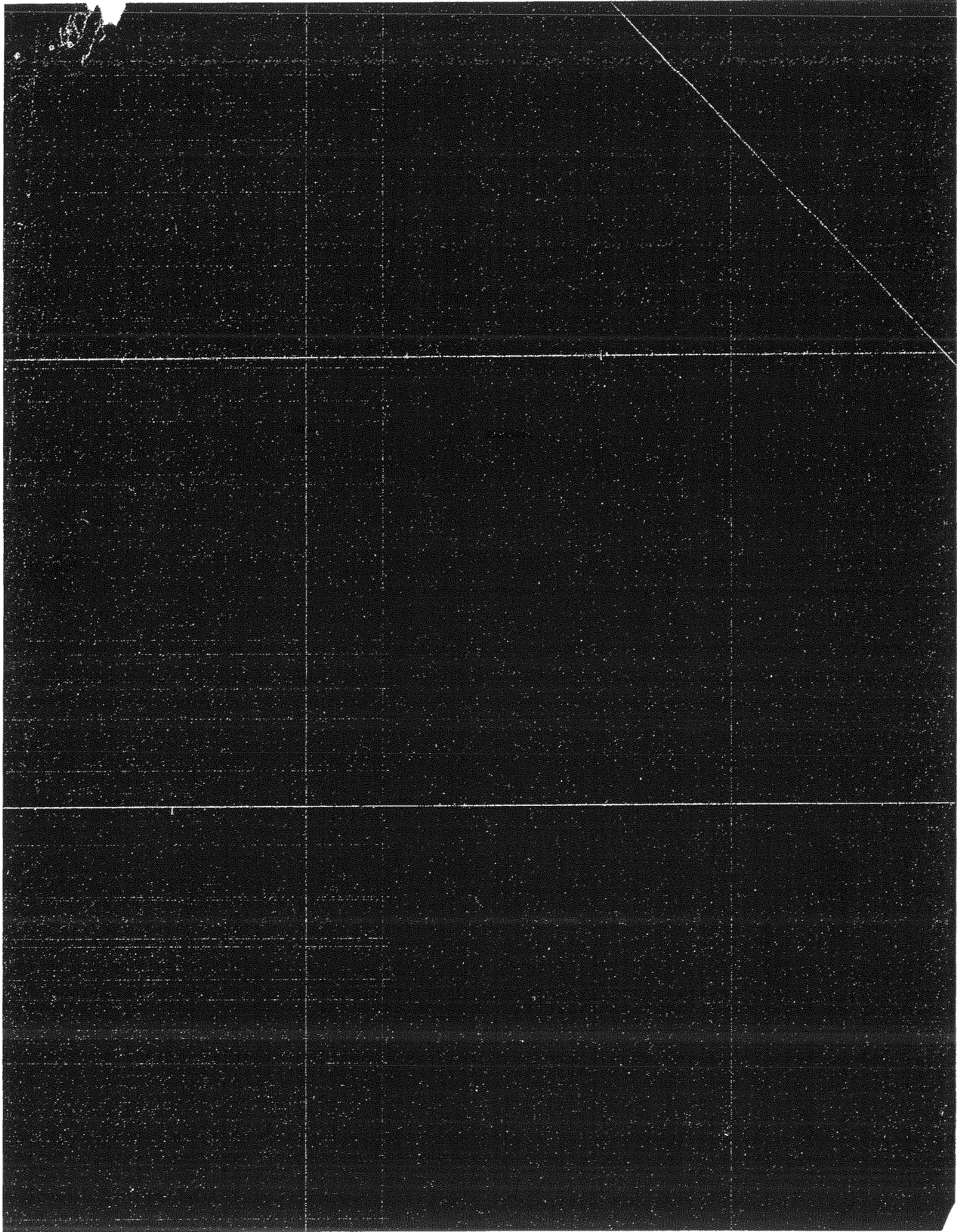
