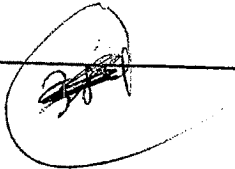

Through personal admission, Mr. Rodriguez has had immoral relations with at least three boys in Troop 739. The Scouts involved are:

These incidents occurred more than once, and in the case of the [redacted] boy, over a long period of time. There does not seem to be any doubt as to the validity of these charges.

Dear Mr. Wallace,

This letter is to inform you that the committee of Troop 739 Manhattan has asked for and received the resignation of its Scoutmaster, Edward A. Rodriguez. It was requested as a safeguard for the boys in our troop, on the grounds of moral turpitude. The events leading up to our request and the following events are detailed in the subsequent paragraph. The explanation may be sketchy in spots as some actions were taken without my knowledge and learned of them second hand.

It is difficult to ascertain as to where to begin but the logical point is to start when our Troop went to summer camp at TMR (July 6, 1964). The boys were to leave on July 6th but our Scoutmaster was to proceed to camp one day earlier (July 5th) with three boys in order to prepare the site and make other arrangements. On July 4th Ed Rodriguez was to meet Mr. [REDACTED], a committee member and father of one of our Scouts, who was to drive them up there at 1:30 P.M. in order to load some equipment into his car for the stay at camp. Ed Rodriguez did not show up. But at 3:00 P.M. another of our parents, Mr. [REDACTED], dropped his son at Alpine. This was done due to the fact that Mr. [REDACTED] was

spending the summer at Spring Valley and his son would then be able to spend the night with Ed Rodriguez at Alpine and meet Mr. [REDACTED] for the trip early Sunday Morning. These Alpine arrangements were made without anyone knowing of it other than the [REDACTED] and Ed Rodriguez. At 4:30 P.M. the same day, July 4th, Ed Rodriguez appeared at Mr. [REDACTED] house and they then proceeded to load the equipment. Mr. [REDACTED] had previously asked Ed Rodriguez to sleep overnight at his house Saturday night to facilitate their early departure. Ed Rodriguez had previously claimed that he had to work Saturday night and again repeated this on Saturday to Mr. [REDACTED]. The boys departed Sunday without any concurrence. The remainder of the troop arrived at camp on Monday. However, the early part of the following week Mr. [REDACTED] visited Mr. [REDACTED] and asked who had slept in his house over the weekend as the house was in a state of disorder. Mr. [REDACTED] did not have any answer for this inquiry. The situation rested until the return of the troop on July 19th. On July 19th Mr. [REDACTED] proceeded to question his son, [REDACTED], as to who had slept in his house and the story evolved that [REDACTED] and Ed Rodriguez had stayed overnight. [REDACTED] also indicated that at this time Ed Rodriguez had engaged in sexual acts with him and had also done so previously on an overnight hike to a Boy Scout camp. He also indicated that two other scouts, [REDACTED] and [REDACTED], were also engaged in similar activities with Ed Rodriguez. Mr. [REDACTED] then informed Mr. [REDACTED] of the information he had gotten from his son and Mr.

██████ began to question his son. His son, ██████, admitted to the episodes also. Both parents agreed then that Mr. ██████ would call Ed Rodriguez and ask for his resignation. For some reason Mr. ██████ called and asked for the resignation, Ed Rodriguez was amazed at this request and wished to know why. He was informed that Mr. ██████ had requested it and if he contacted Mr. ██████ he would be informed as to the reason. All these events between Mr. ██████ and Mr. ██████ occurred on Sunday July 19th, the day the boys returned from TMR. That evening Ed Rodriguez called Mr. ██████ in Spring Valley and was told of the information received from the two boys. He denied the happenings but on further conversation with Mr. ██████ he neither denied nor confirmed them. On Monday Mrs. ██████ called the Boy Scout Council in the Spring Valley area and asked for advice. The advice that she received of what transpired at that time unfortunately is not within my knowledge as I have not spoken to the ██████ at any time. All my information has been received from Mr. ██████. I was informed though that there were several phone calls made to Mrs. ██████ by Ed Rodriguez wherein he admitted his involvement. I first became aware of this situation on Monday evening (July 20th) when I spoke to Mr. ██████. He also indicated that Ed Rodriguez had just called him and asked to see him personally on Wednesday, July 22nd. Mr. ██████ and myself decided to keep the situation known in as small an area as possible and as such invited the following people besides ourselves to the meeting with Ed Rodriguez.


- 1) Mr. Warren Towns - Institutional Rep.
- 2) Mr. [REDACTED] - who did not attend
- 3) Mr. Benjamin Munk - Committee Treasurer
- 4) Mr. [REDACTED] - whose son may have been involved

Mr. [REDACTED] also stated that his son was examined by a doctor and no evidence of disease was found at this time. We questioned Ed Rodriguez and he readily admitted his guilt. He also stated that the episodes were confined only to two scouts, [REDACTED] and [REDACTED], and that they occurred only 3-4 times with each. He didn't give any reason why he had chosen these boys in particular but as a matter of fact these boys are small in stature. The third boy had been questioned previously by his father and there weren't any indications that anything occurred. Ed Rodriguez also indicated no involvement with [REDACTED]. Ed Rodriguez also indicated that this is the first time that this had happened but those present were of the opinion that his activities definitely were repeated previously with others. All through the questioning he indicated remorse for what he had done and seemed quite penitent. We advised him of the possible legal consequences of his acts and he appeared well aware of them. However, Mr. [REDACTED] does not wish to prosecute and Ed Rodriguez was informed of this with the proviso that he must seek psychiatric help and inform us of his efforts and progress. He was quite appreciative of our leniency and our efforts to help him help himself and as such our meeting came to an end. Before ending, though he was requested not to divulge any information connected with the affair, nor was he to frequent our area. He

also was directed to send all records, merit badge applications to me. At this moment we feel that any connection we have had with Ed Rodriguez has been severed. The only future contacts with him will be to ascertain if he is following through on his promise to seek aid. We feel that we have been quite lucky in that this situation did not spread further and involve more of our troop members and we now must minimize the damage that has been done to the two scouts involved. One of our principal goals is to make the two boys aware of the fact that this matter has been treated confidentially and will not be revealed to anyone else. We have even gone so far as to concoct a reason why Ed Rodriguez has left the troop.

To my knowledge these are the events leading up to the resignation of our Scoutmaster. I hope I have clearly stated the facts and you concur in our course of action. If any other information is required feel free to contact me at my home or office. I hope that our experience will be of some benefit by insuring that Ed Rodriguez will not be allowed to hold any position anywhere in the Boy Scouts of America. In this way we can ease our consciences with respect to any other boy engaged in scouting coming into contact with him.

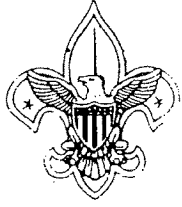
