Over the past year or two, we have been hearing numerous stories concerning Mr. Schultz - his leadership, personal habits, and vacation trips with two or three boys. The stories had to do with profane language, dirty stories, and promoting cigarette smoking among Scouts on overnight Troop camping trips.


The incident that gave me the privilege of eliminating this man from association with boys in Scouting, has to do with his contact with [REDACTED]. This boy came home from a camping trip this spring with the following story:

On a cold evening of the week-end camp-out, he was invited to sleep in the station wagon with Mr. Schultz. He returned home tired and upset, after a night of what he called "pawing of his body, and handling of his penis."

This is all I have to report at this time. I can, if you feel you need it, get a statement to this effect from the boys parents.

I discussed the incident with Mr. Schultz, and he did not deny it. I pointed out the seriousness of the complaint, and he submitted his resignation, prompted by the threat of prosecution by the [REDACTED] family - as per copy of letter on file with you.
