GENTLEMEN:

I HAVE THIS DATE READ A VOLUNTEERED AND SIGNED STATEMENT OF THE ABOVE NAMED PERSON REGARDING HOMOSEXUAL AND PROCUREMENT ACTIVITIES IN THIS AREA. WHILE THERE IS INSUFFICIENT EVIDENCE TO SUPPORT BRINGING THIS PERSON TO TRIAL OR PLACE FORMAL CHARGES AT THIS TIME, THE RECORD IS CARRIED AT THE WEST PALM BEACH POLICE DEPARTMENT.

IN THIS STATEMENT HARRY RICHARD WATSON, III ADMITS ACCOSTING A JUVENILE BOY ON A SOUTHBOUND BUS IN ROUTE TO LAKE WORTH WITH A NOTE ESTABLISHING A TIME AND PLACE AND OFFERING PAY FOR A RENDEZVOUS. IN HIS SIGNED POLICE STATEMENT WATSON INDICATED HE (WATSON) WAS TO RECEIVE MONEY FOR PROCUREMENT OF THIS BOY FOR ANOTHER MAN. THIS OFFENSE REPORTED BY THE LAKE WORTH POLICE DEPARTMENT WAS INVESTIGATED BY THE WEST PALM BEACH DEPARTMENT FOR THE ADDRESS FOR THE ABOVE RENDEZVOUS WAS IN WEST PALM BEACH. FURTHER IN THE STATEMENT HE ADMITTED OTHER CHARGES ALSO ON RECORD IN WEST PALM BEACH OF ACCOSTING JUVENILES.

THIS MAN IS REGISTERED AS 22 YEARS OF AGE ALTHOUGH THE POLICE RECORDS SHOW HIS AGE AS NINETEEN AND BIRTH DATE AS OCTOBER 11, 1941. HE IS FIVE FEET ELEVEN AND ONE QUARTER INCHES TALL, MEDIUM COMPLEXION, BROWN HAIR, 190 LBS., AND HAS HAZEL EYES. HE IS OF STOCKY BUILD AND IS LEFT-HANDED. HE HAS A FAINT, ONE-HALF INCH, CURVED SCAR ABOVE AND IN HIS RIGHT EYEBROW. HE HAS BEEN EMPLOYED LOCALLY AS A HANDYMAN, INTERIOR DECORATOR, AND IS NOW EMPLOYED BY THE S & S CAFETERIA IN WEST PALM BEACH. HIS REGISTERED ADDRESS IS 2207 SOUTH DIXIE, WEST PALM BEACH, HOWEVER, ACCORDING TO POLICE RECORDS HE HAS MOVED TWICE SINCE GIVING THIS ADDRESS TO 212 1/2 VALLETTE WAY, WEST PALM BEACH AND IS NOW RESIDING AT THE FOUR SEAS MOTEL IN LAKE WORTH.

THE ABOVE OFFENSE TOOK PLACE ON JUNE 28, 1961.
