We have reviewed the case concerning the above Scouter, sent to us by your predecessor Schiller Colberg, with our Attorney and have now placed this man on the Confidential File.

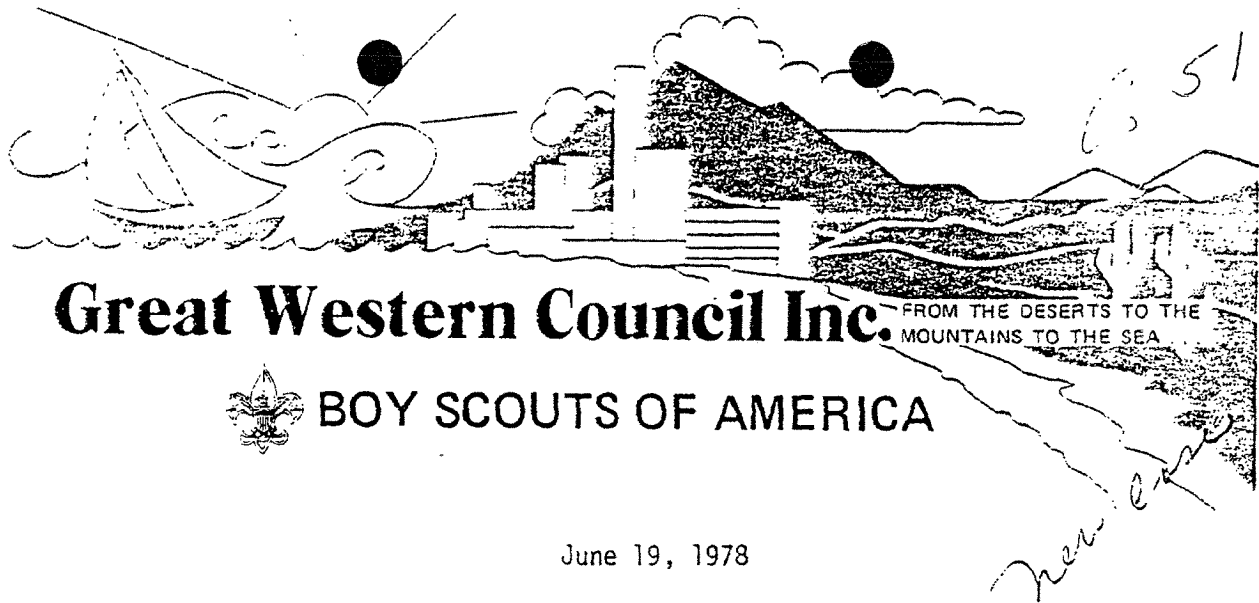

SUBJECT: Homosexual Charge Against Keith Dunn

Don Pittenger was working on the charge brought against Keith Dunn by the grandmother of a Scout, whose name is Mrs. [REDACTED] telephone number 559-5129. We had been informed by the Scoutmaster of Troop 123, [REDACTED] that his Assistant Scoutmaster, Keith Dunn was engaged in unlawful activities of a sexual nature with one or more Scouts. He called today and asked what was happening.

I called Mrs. [REDACTED], she gave the names of two police officers, Havel and Adams, who had come to her home and to whom she and her grandson had made a complaint (we have copies of this complaint at our office on Palms Blvd.).

I called the Juvenile Division, 485-2883 at 221 South Hill St., Los Angeles and talked to the supervisor of these two gentlemen.

Because they were out, he told me that they had talked to Keith Dunn and he had confessed. He further said he is sick mentally, that they will pick him up next week and seek psychiatric help to care for his illness.

I told him that we do not want Dunn associating in Scouting and I will inform the National office about these series of events and that Dunn can no longer participate in the Scouting program in the U.S.A.

ON THE OUTSIDE OF VICT'S CLOTHING. VICT STATED THE SECOND TIME OCCURRED ON THURSDAY, MAY 18, 1978, WHEN SUSP TOOK VICT TO SUSP'S RESID. WHILE AT SUSP'S APT, SUSP TOLD VICT THAT HE (SUSP) WANTED TO PLAY STRIP POKER. SUSP EXPLAINED THAT WHEN VICT LOST A HAND, HE (VICT) HAD TO TAKE OFF A PIECE OF CLOTHING. VICT & SUSP PLAYED UNTIL VICT HAD ONLY HIS UNDERSHIRTS & UNDERSHIRT ON. SUSP TOLD VICT TO TAKE OFF HIS (VICT) UNDERCLOTHES, & IF VICT DIDN'T DO IT, SUSP WOULD DO IT FOR HIM. WHEN VICT WAS NAKED, SUSP REMOVED HIS CLOTHES & APPROACHED VICT & STATED, "IN STRIP POKER, AFTER TAKING OFF YOUR CLOTHES, YOU HAVE TO PLAY THROUGH." VICT STATED SUSP'S PENIS WAS UPRIGHT & ERECT, & TOLD VICT, "IF YOU POP IT, YOU WILL GET A BOMBER, LIKE I HAVE." SUSP THEN STROKED VICT'S PENIS WITH HIS FINGERS, & BEAT VICT'S PENIS. VICT STATED SUSP THEN SLICKED ON VICT'S PENIS. VICT STATED SUSP THEN FORCED VICT TO SUCK ON SUSP'S BUST PENIS. SUSP THEN TOLD VICT, "IF YOU OPEN YOUR MOUTH, (TO ANYONE) I AM GOING TO KILL YOU." VICT STATED HE WAS AT SUSP'S APT FOR APPROX. TWO HOURS, & SUSP THEN DROVE VICT HOME. VICT TOLD HIS GRANDMOTHER THE FOLLOWING NIGHTS & SUSP RETURNED TO VICT'S RESID ON WED, MAY 24TH TO GIVE VICT'S BROTHER (KIRK) HIS FINAL TEST IMPLAST AID FOR AERIAL BIDS. AT THAT TIME, GRANDMOTHER CONFRONTED SUSP ABOUT INCIDENT, & SUSP ADMITTED ACT STATING, "I'VE GOT PROBLEMS. I AM GOING TO QUIT MY JOB, & ADMIT MYSELF INTO CAMPBELL." GRANDMOTHER STATED, "WHY DON'T YOU GET A WIFE & LEAVE SMALL KIDS ALONG." SUSP STATED, "GIRLS DON'T HAVE ANYTHING TO DO WITH ME." SUSP RETURNED ON SATURDAY, MAY 27TH, 1978, & TALKED TO VICT'S GRANDMOTHER, HE (SUSP) WANTED TO TALK TO BISHOP (BISHOP OF MORNING CHURCH) ABOUT HIS (SUSP) PROBLEM, & BISHOP WOULD CALL GRANDMOTHER IN ABOUT A WEEK. GRANDMOTHER STATED SHE THEN CALLED POLICE. VICT STATED HE ASKED ANOTHER BOY IN TROOP, [REDACTED] M-W-12 YRS - IF SUSP HAD TOUCHED HIM ([REDACTED]) & [REDACTED] OLD VICT YES.
