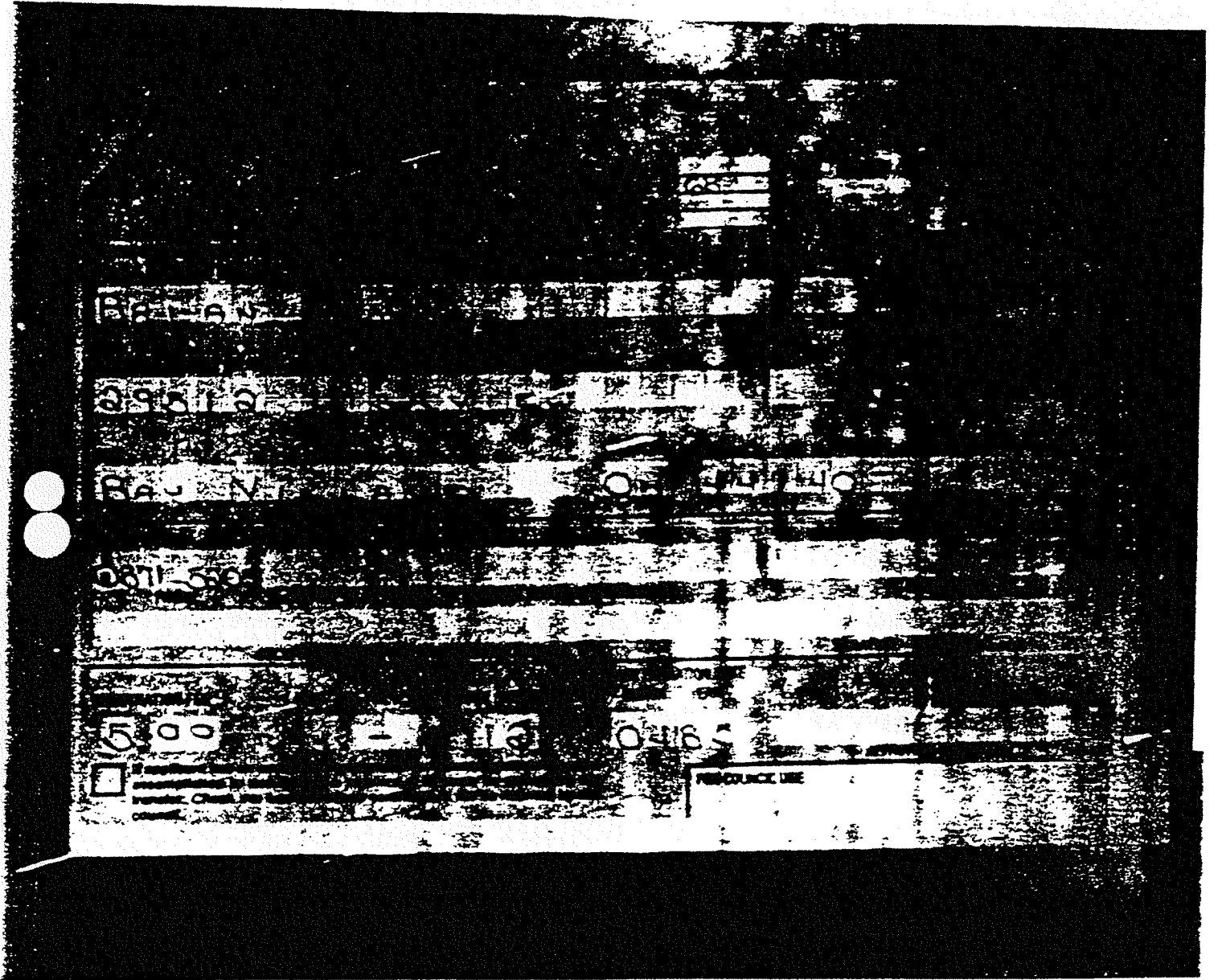



Dear Paul:

One of our Scoutmasters should not be registered with the Boy Scouts of America. He is Brian Keyes, 29512 Lisaview, Bay Village, Ohio 44140. Troop 68 is chartered to the Lakewood Christian Church.

The first concern came to our attention on February 25. Police Officer [REDACTED] of the Lakewood Department called to tell us that Brian Keyes had had some problems with youth in Lorain County. On checking, I found out that he had been convicted in July, 1984 for contributing to the delinquency of a minor. Apparently, there were thirteen counts which were reduced to two counts.

I talked to his probation officer, Donald Feldcamp, who would release little information except to say that he was having a meeting with Mr. Keyes on that same day to tell him that he was to have absolutely no contact or association with children and youth, effective immediately.

Jeff Norton, our district executive, reviewed this information with the pastor and the troop committee chairman. Following a meeting of the troop committee, Mr. Unger, the troop committee chairman, called Mr. Keyes. He readily resigned without any problems. A letter from Mr. Unger is attached.

Based on this information we believe that Brian Keyes should not have any association with the Boy Scouts of America now or in the future.
