A Duxbury man will be on probation for two years after pleading guilty to a morals offense involving an eight-year-old Middleboro girl.

Judge L. Francis Callan in Fourth District court Saturday sentenced Cleophus B. L'Heureux, 44, to a three-month term in the House of Correction and then suspended the term in favor of probation. L'Heureux spent 35 days in the Taunton Hospital for observation after pleading guilty on Aug. 30. Complaint was Patrolman Joseph M. Quelle.

A Duxbury father of five children was sent to the Taunton State Hospital for 35 days observation after trial before Judge L. Francis Callan in Fourth District court, Middleboro, Wednesday.

Cleophas E. L'Hendoux, 41, was ordered committed after being charged with morals offenses by Patrolman Joseph E. Quelle. L'Hendoux, a Providence marine insurance man was arrested Tuesday night after a complaint was received from the father of an eight-year-old Middleboro girl. The case was continued to Oct. 10 for finding and disposition.

Albert Barboza, 25, of 37 Cedar street, Wareham, was fined \$300 for deriving support from the earnings of a prostitute in Lakeville July 30. He was given until Saturday to pay the fine. State Trooper Carl Cederquist told the court that the offense involved a Rochester woman and seven men.

Breaking and entering a Mattapoisett tavern and the theft of 14 bottles of liquor cost Stephen Pereira, 24, of 44 St. James street, Fall River, a \$75 fine. Payment was suspended to Sept. 13. Complainant was Chief Alden C. Kinney of Mattapoi-
