**Attempted to register as ACM when new Pack was being formed, but reg. not accepted due to criminal record discovered when inquiry was sent here ~~xxxxxxxxxxxxxxxx~~ relative to another "George Jones"

Recommended for Confidential File for following reasons:

Confidential records in office of Alachua County Sheriff show he was sent to Fla. State Prison in Raiford, Fla. 3-1-61 for "breaking and entering". Paroled May 15, 1962. Arrested for withholding support by Alachua County officers and turned over to Sarasota County Sheriff's office Nov. 19, 1963. Was apparently allowed to return to Gainesville, and on Jan. 31, 1964 he was arrested for rape and violation of parole, and is now (3-5-64) in Alachua County Jail, without any bond set, awaiting trial. Record summary from FBI, in Alachua Co. files, shows other arrests back to 1959, but no disposition of charges (breaking and entering, vagrancy). There is no doubt (identification of picture) that this is the same man who tried to register as ACM, Pack 373. (Motive for lying about his age, or for trying to register in Scouting is not known - it is possible he thought the GC-204-31 card might be used some way).

Thanks very much for the letter correcting the information concerning George Jones, Jr. Accidents of this type, though not too common, can easily occur. We just simply have to ascribe it to "One of those things". We do very much appreciate your advising us of the error and in particular the information concerning the George Jones in whom we were interested.

It is apparent, from the Confidential Inquiry Report, that our George Jones is still not the same individual as the one who registered as Assistant Cubmaster in Pack 373. However, the information you have now provided clearly supports your judgment that George Jones, Jr. should now be added to our Confidential File. We have taken this action and have deleted him from the unit records.

So as to avoid further complications in identity and so as to provide us with all possible information, will you please complete the enclosed confidential record sheet and return it to us for our files. This information will enable us to identify Mr. Jones if he should ever again attempt to register in the Scouting program.

Since his certificate was mailed back to your office earlier this month, it may be that it was routine procedure to forward it on to him, in which case, you may want to ask him to return it. We will leave whatever action which should be taken locally in your hands.

A refund of \$1.00, for Mr. Jones' registration, is enclosed.

The Confidential Inquiry-Report of November 18, 1963 was received concerning, George Jones, Jr., Assistant Cubmaster of Pack 373. The latter part of December a Confidential Report was submitted to the Registration Service concerning George Jones.

An investigation was carried on concerning this individual, but unfortunately the wrong George Jones was investigated and the report which was mailed to you in December was actually on the wrong individual.

I am enclosing another report (Confidential Inquiry) on George Jones, Jr.. Through additional investigation we have found that he is not the calibre of individual which we can register. Therefore, I think it would be advisable to include this information in the confidential files, for it has been thoroughly investigated by our District Executive serving in that area.

I sincerely regret the error on the individual which we sent in previously, but hope that it will not cause too much additional work and effort in your Department.
